Notice is hereby given, pursuant to Section 16-50l(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application submitted to the Connecticut Siting Council ("Council") on January 22, 2021 by Burlington Solar One, LLC and its affiliates (the "Applicant"). The Application proposes the installation of a 3.50 megawatt (MW) solar-based electric generating facility (the "Project") located at Lot 33, Prospect Street, Burlington, Connecticut (the "Project Site"; or the "Site"). The site is contained within a 62.98-acre parcel of land, entirely within the Town of Burlington. The Applicant proposes to construct the solar project within a fenced facility compound on an 11.58-acre development area of the Site. The Project will include fencing, inverters, and equipment to interconnect the project with the electrical system of the Connecticut Light & Power Company, d/b/a Eversource Energy.
