Continuation of Evidentiary Hearing

The Council shall continue the evidentiary hearing session for the above-referenced proceeding on **June 24, 2021**, via Zoom conferencing, beginning at **2:00 p.m.** A copy of the Instructions for Access to the Continued Evidentiary Hearing is attached.

The hearing shall commence with the continued cross examination of the Applicants by Stan Greenbaum, followed by further cross examination of the Applicants by the Council and thereafter, continue with the appearance of Stan Greenbaum for cross examination by the Council and the Applicants.

Applicant's Late-Filed Exhibits

During the May 25, 2021 evidentiary hearing session, the Council requested that the Applicants submit the following information as late-filed exhibits:

- a) Provide the anticipated schedule for Litchfield County Dispatch to locate on the facility, if it is approved;
- b) Submit revised coverage plots that show legible AT&T site ID numbers for existing facilities;
- c) Provide information regarding Town of Sherman requirements for site blasting; and
- d) Submit the Slimy Salamander survey report.

The Council requests these late-filed exhibits be submitted to the Council before the close of business on **June 17, 2021**.

Any request for an extension of time to submit the above-referenced late-filed exhibits, pre-filed testimony and responses to interrogatories shall be submitted to the Council in writing pursuant to §16-50j-22a of the Regulations of Connecticut State Agencies.
