Motions

During a public hearing of the Connecticut Siting Council (Council) held on June 24, 2021, the Council ruled on the following motions:

1. Applicants' Motion for Protective Order Related to Disclosure of the Compensation and Financial Information in the Letter Agreement Between Homeland Towers, LLC and the Owner of Coote Hill Road, dated June 17, 2021

The motion was granted.

2. Applicants' Motion on the Scope of Intervenor Greenbaum's Participation, to Compel Disclosure of Intervenor's Witnesses and to Exclude Certain Intervenor Exhibits and Pre-Filed Testimony, dated June 18, 2021

A. Request to Limit Scope of Intervenor Greenbaum's Participation

The request was granted to limit Intervenor Greenbaum's participation to matters that are jurisdictional to the Council pursuant to the Public Utility Environmental Standards Act, which include environmental impacts and consideration of available alternative sites, but do not include the evaluation and/or determination of private property rights.

B. Request to Compel Disclosure of Intervenor Greenbaum's Witnesses

The request to compel disclosure of Intervenor's witnesses was rendered moot by Intervenor Greenbaum's June 23, 2021 and June 24, 2021 responses to Applicants' request.

C. Request to Exclude Certain Intervenor Pre-Filed Testimony and Exhibits

The request was granted as it relates to Intervenor Greenbaum's June 17, 2021 submission as follows:
