Dear Attorney Berman:

In response to your request, at the November 3, 2016 evidentiary hearing, pursuant to Connecticut General Statutes §16-50n, §4-177a and §22a-19, the Connecticut Siting Council (Council) granted the Sierra Club Party and CEPA Intervenor status in Docket No. 470 with the condition that the Sierra Club submit an application to the Council with copies to the service list on or before December 30, 2016 for an attorney not licensed to practice in Connecticut to participate in this state agency proceeding in compliance with the amended Pro Hac Vice Rule under §2-16 of the Superior Court Rules that takes effect January 2017 or, in the alternative, submit a written description as to why Sierra Club is not subject to the amended Pro Hac Vice Rule. Pursuant to Connecticut General Statutes §16-50n(c), the Council grouped Sierra Club with Not Another Power Plant.

All filings submitted to the Council must consist of an original and 15 copies with the docket number, properly collated and paginated, and bound. In accordance with Section 16-50j-12 of the Regulations of Connecticut State Agencies and with the State Solid Waste Management Plan, the Council is requesting that all filings be submitted on recyclable paper, primarily regular weight white office paper. Please avoid using heavy stock paper, colored paper, and metal or plastic binders and separators. It is also requested that an electronic version of all filings be sent to sitting.council@ct.gov.

The Council's preferred service to parties and intervenors is electronic mail. If you wish to receive hard copies of documents via regular mail, please notify the Council in writing. Parties and intervenors are required to serve all other parties and intervenors a copy of any material submitted in this docket, unless service is waived. A copy of the current service list can be found on the Council's website for this proceeding.

Copies of all documents filed to date in this proceeding are available for your review at the Council's office and on the Council's website under Pending Matters. On the Council website you may sign up for our ealert service which sends emails when the agenda, agenda minutes, and Pending Matters sites are updated.
