RE: **DOCKET NO. 190B** – Meriden Gas Turbines, LLC Certificate of Environmental Compatibility and Public Need for a 530 MW combined cycle generating plant in Meriden, Connecticut. Reopening of this docket pursuant to Connecticut General Statutes § 4-181a(b) limited to Council consideration of changed conditions and Decommissioning Plan.

Directions to Meriden City Hall

The Meriden City Hall is located at 142 East Main Street in Meriden, Connecticut.

- From eastbound or westbound on I-691, take exit 8 onto Broad Street/Route 5.
- At end of exit ramp, turn left onto Broad Street.
- Follow Broad Street to Liberty Street and turn right. Liberty Street will be approximately .6 mile from the I-691 westbound exit ramp and .5 mile from the I-691 eastbound exit ramp.
- On Liberty Street, Meriden City Hall will be approximately .3 mile on left. There is a municipal parking lot across from City Hall on the right. Council members are asked to meet in this parking lot where the City's bus will be waiting.

To Restaurant

Dinner will be at Sans Souci Restaurant, 2003 North Broad Street (Berlin Turnpike) in Meriden.

- From Meriden City Hall, take Liberty Street back to Broad Street and turn left onto Broad Street.
- Broad Street will merge with the Wilbur Cross Parkway/Berlin Turnpike.
 Restaurant is on right, shortly after this merge. Restaurant will be approximately 2.7 miles from the intersection with Liberty Street.
