An application by Towantic Energy, LLC for a Certificate of Environmental Compatibility and Public need for the construction, maintenance and operation of a proposed 805 MW electronic generating "Facility" located north of the Prokop Road and Towantic Hill Road intersection in the Town of Oxford, Connecticut.

Dear Ms. Bachman:

The Naugatuck River Revival Group, Inc as a 501 (c) (3) organization wishes to be granted Intervenor Status in the proceedings regarding Docket 192B.

In support of this request the NRRG is concerned for the general health and welfare of the Naugatuck River, the wildlife, its impaired and fragile ecosystem and the residents and tourists that recreate in and along its waters.

We are a non-profit group dedicated to the eradication of trash and debris in and along the Naugatuck River, to reviving its beauty and improving conditions for the wildlife that live in and around the river. The NRRG educates the public about safe recreational use of the river. The NRRG creates documentaries about the wildlife, its impairment, Greenway development and recreational use along the river for education purposes. We are presently uniting all 11 towns and cities along Connecticut's largest in-state river in an effort to start Trash Excluder Pilot Program's and assisting CT DEEP in the possibility of writing Connecticut's first Trash TMDL for the Naugatuck River.

The discharge of treated effluent from the "Facility" in general and the potential for creating CSO (Combined Sewer Overflow) during increasingly frequent extreme storm events are of particular concern. This "Facility" may have significant detrimental effects on the operation of the Naugatuck Wastewater Treatment Plant and its ability to process and treat the unknown amount and unknown content of "grey water" from the proposed dual-fuel "Facility".

The NRRG documents, cleans and protects the Naugatuck River's unique and fragile ecosystem and will actively resist any future and further negative economic externality caused by a development that adds pollutants into this increasingly improved yet (still) impaired Naugatuck River.

The NRRG seeks full rights as an Intervenor. It is important to the NRRG that this "Facility", if built, "does no harm" to the Naugatuck River ecosystem and sets back, in any way, the forward progress made over the past 14+ years to the quality of life to humans, animals (both terrestrial and avian) and aquatic life. Our documentaries show the recreational use and what exists and what needs to be protected. The NRRG will not impair the orderly conduct of these proceedings and seeks to assist the Council in making an informed decision in this case.

We believe it is imperative that further study be done to determine the volume, quality and exact content of the "grey water". We need to know what failsafe guards will be used to prevent any temperature increase to the Naugatuck River. We believe that the structural integrity of the Oxford municipal sewer system used to transport this added effluent be fully accessed assuring no uncalculated ground water enters the Oxford municipal sewer system, thus adding to the volume of water going to the Naugatuck Wastewater Treatment Plant.

It is of prime importance that the Naugatuck Wastewater Treatment Plant and the Oxford municipal sewer system can handle all new "Facility" effluent created while operating at capacity on both Natural Gas and Oil and properly treat it before discharging it into the Naugatuck River so it "does no harm".

Please advise us if additional information is required in order for the CSC to approve us as an Intervenor to the Docket 192B proceedings.
