LEGAL NOTICE

Notice is hereby given pursuant to Section 16-501(b) of the Connecticut General Statutes and Section 16-501-1(e) of the Regulations of Connecticut State Agencies of an Application to be submitted to the Connecticut Siting Council ("Siting Council") on June 18, 2007, or thereafter by Optasite Towers LLC and Omnipoint Communications, Inc., a subsidiary of T-Mobile USA, Inc. ("T-Mobile") (collectively the "Applicants"). The Applicants will request a certificate of environmental compatibility and public need from the Siting Council for the construction, maintenance and operation of a telecommunications facility in New Milford, Connecticut. The Applicants are proposing to construct a new monopole tower at 425 Litchfield Road, New Milford, Connecticut and is owned by the Estate of Edward J. Drazil (the "Property"). The Applicants propose to construct a new 140' self-supporting monopole tower, antennas, associated equipment and other site improvements integral to a wireless communications facility. The location, height and other features of the proposed facility are subject to review and potential change under provisions of the Connecticut General Statutes §16-50g et. seq.

A balloon representative of the proposed height will be flown on the day of the Siting Council public hearing on the application, which will take place in the Town of New Milford. The balloon will be flown from approximately 8:00 a.m. to 6:00 p.m. Notice of the public hearing date will be provided by the Siting Council.


