

NOTICE

Notice is hereby given, pursuant to Section 16-501(b) of the Connecticut General Statutes and Section 16-501-1(e) of the Regulations of Connecticut State Agencies of an Application to be submitted to the Connecticut Siting Council (“Siting Council”) on June 25, 2007, or thereafter by MCF Communications bg, Inc. (“MCF”) and Omnipoint Communications, Inc., a subsidiary of T-Mobile USA, Inc. d/b/a T-Mobile (“T-Mobile”) (collectively the “Applicants”). The Applicants will request a certificate of environmental compatibility and public need from the Siting Council for the construction, maintenance and operation of a telecommunications facility in Groton, Connecticut. The Applicants are proposing to construct a new monopole tower at 237 Sandy Hollow Road, Groton Connecticut and is owned by the Mystic River Ambulance Association Inc. (the “Property”). The Applicants propose to construct a 130 foot, self-supporting monopole, antennas, associated equipment and other site improvements integral to a wireless communications facility. The location, height and other features of the proposed facility are subject to review and potential change under provisions of the Connecticut General Statutes § 16-50g *et. seq.*

The proposed Facility will provide service in the Town of Groton, along Interstate I-95 as well as in adjacent areas. The Application will explain the need, purpose and benefits of the facility and will also describe the environmental impacts of the proposed facility.

A balloon representative of the proposed height will be flown on the day of the Siting Council public hearing on the Application, which will take place in the Town of Groton. The balloon will be flown from approximately 8:00 a.m. to 6:00 p.m. Notice of the public hearing date will be provided by the Siting Council.
