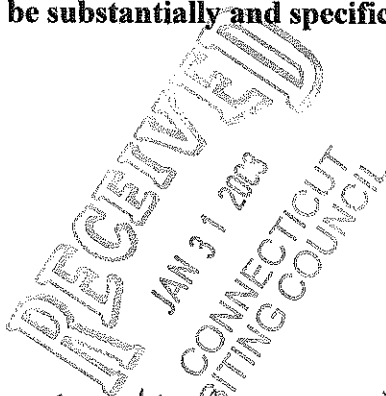

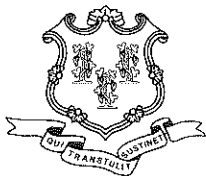
**6. Other comments for the Siting Council's consideration:**


We are in receipt of your letter of January 28, 2008, requesting Party status in Docket No. 348.
