To Site

Site is located on Boston Post Road (Route 1) north of Exit 57 on I-95.

From I-95 Northbound:

- Take exit 57;
- Turn left onto Boston Post Road at end of exit ramp (existing tower will be visible);
- From Boston Post Road, turn right after Guilford Self Storage sign;
- Follow paved road to site.

From I-95 Southbound:

- Take exit 57;
- Turn right onto Boston Post Road at end of exit ramp (Guilford Sporting Goods will be on right)
- From Boston Post Road, turn right after Guilford Self Storage sign;
- Follow paved road to site.

To Hearing

Hearing is at the Guilford Fire Department in the Guilford Public Safety Complex, 390 Church Street (Route 77), which is just north of exit 58 on I-95.

From Site, turn left onto Boston Post Road;
Follow to intersection with Route 77;
Turn left onto Route 77 – Church Street;
Guilford Public Safety Complex will be on left shortly beyond bridge over which I-95 crosses Route 77;
Fire Department building is straight ahead, toward rear of complex.

General directions, from I-95 take exit 58;
If traveling northbound on 95, turn left onto Church Street (Route 77);
If traveling southbound on 95, turn right onto Church Street (Route 77);
Guilford Public Safety Complex will be on left shortly beyond entrance to I-95 southbound;
Fire Department building is straight ahead, toward rear of complex.

To Restaurant

Dinner will be at First and Last Tavern at 535 Boston Post Road (203/458-1400). It is located just south of exit 59 on I-95.

From fire department, turn right onto Church Street;
Turn left onto Boston Post Road at intersection of Routes 77 and 1;
First and Last will be approximately one mile on left.
