From Northwest Connecticut (Norfolk area):

Take Route 44 East to Interstate 84 East.
Proceed on I-84 East.
Take Exit 73 (Route 190) off of I-84 East.
Turn right onto Buckley Highway (Route 190).
Proceed on Route 190 for about 1.9 miles.
Turn right onto Bigelow Hollow Road (Route 171).
Proceed on Route 171 for about 2.2 miles.
Continue straight onto Lawson Road (Route 197).
Proceed on Route 197 for about 1.8 miles.
Turn right onto Black Pond Road (Route 198).
Proceed on Route 198 for about 0.7 miles.
The site and the applicant's sign are on the left side.
Route 198 is narrow with limited space for parking.
Parking on Windswept Drive (ahead on the right) is suggested.

Via I-395 from points east of I-395 (Stonington area):

Take Interstate 95 South to I-395 North.
Proceed on I-395 North.
Take Exit 95 off of I-395 North.
Turn right on the end of the ramp onto Kennedy Drive.
Proceed straight on Kennedy Drive for roughly two miles.
Turn left onto Bridge Street. (It's a bridge that crosses the Quinebaug River.)
Proceed straight onto Woodstock Avenue (Route 171).
Continue on Route 171 to the Woodstock Town Line.
Continue on Route 171 for about 1.3 miles.
Continue straight onto Route 169 / 171.

Turn left onto Route 171 Somers Turnpike.

Via I-395 from points west of I-395 (Milford, Fairfield area):

Take I-95 North to Exit 76 (I-395 North).
Proceed on I-395 North.
Take Exit 95 off of I-395 North.
Turn right on the end of the ramp onto Kennedy Drive.
Proceed straight on Kennedy Drive for roughly two miles.
Turn left onto Bridge Street. (It's a bridge that crosses the Quinebaug River.)
Proceed straight onto Woodstock Avenue (Route 171).
Continue on Route 171 to the Woodstock Town Line.
Continue on Route 171 for about 1.3 miles.
Continue straight onto Route 169 / 171.
Turn left onto Route 171 Somers Turnpike.
Continue on Route 171 for approximately 6.7 miles.

Via Interstate 84:

From Site

Proceed south on Route 198 (Black Pond Road) passing by Old Turnpike Road.
Continue straight on Route 198 for about 2.4 miles.
Take a sharp left onto Somers Turnpike (Route 171).
Follow Route 171 (approx. 6.7 miles) until it intersects Route 169.
Turn left onto Route 169 (Norwich-Worcester Turnpike).
Proceed on Route 169 for about 0.7 miles.
The Woodstock Town Hall is on the right located at 415 Route 169.

Via Interstate 395 North or South

Proceed on I-395 North or South.
Take Exit 95 off of I-395.
Turn right on the end of the ramp onto Kennedy Drive.
Proceed straight on Kennedy Drive for roughly two miles.
Turn left onto Bridge Street. (It's a bridge that crosses the Quinebaug River.)

Proceed straight onto Woodstock Avenue (Route 171).
Continue on Route 171 to the Woodstock Town Line.
Continue on Route 171 for about 1.3 miles.
Continue straight onto Route 169 / 171.
Continue straight onto Route 169 (Norwich-Worcester Turnpike).
The hearing location is about 0.7 miles ahead on the right, located at 415 Route 169.

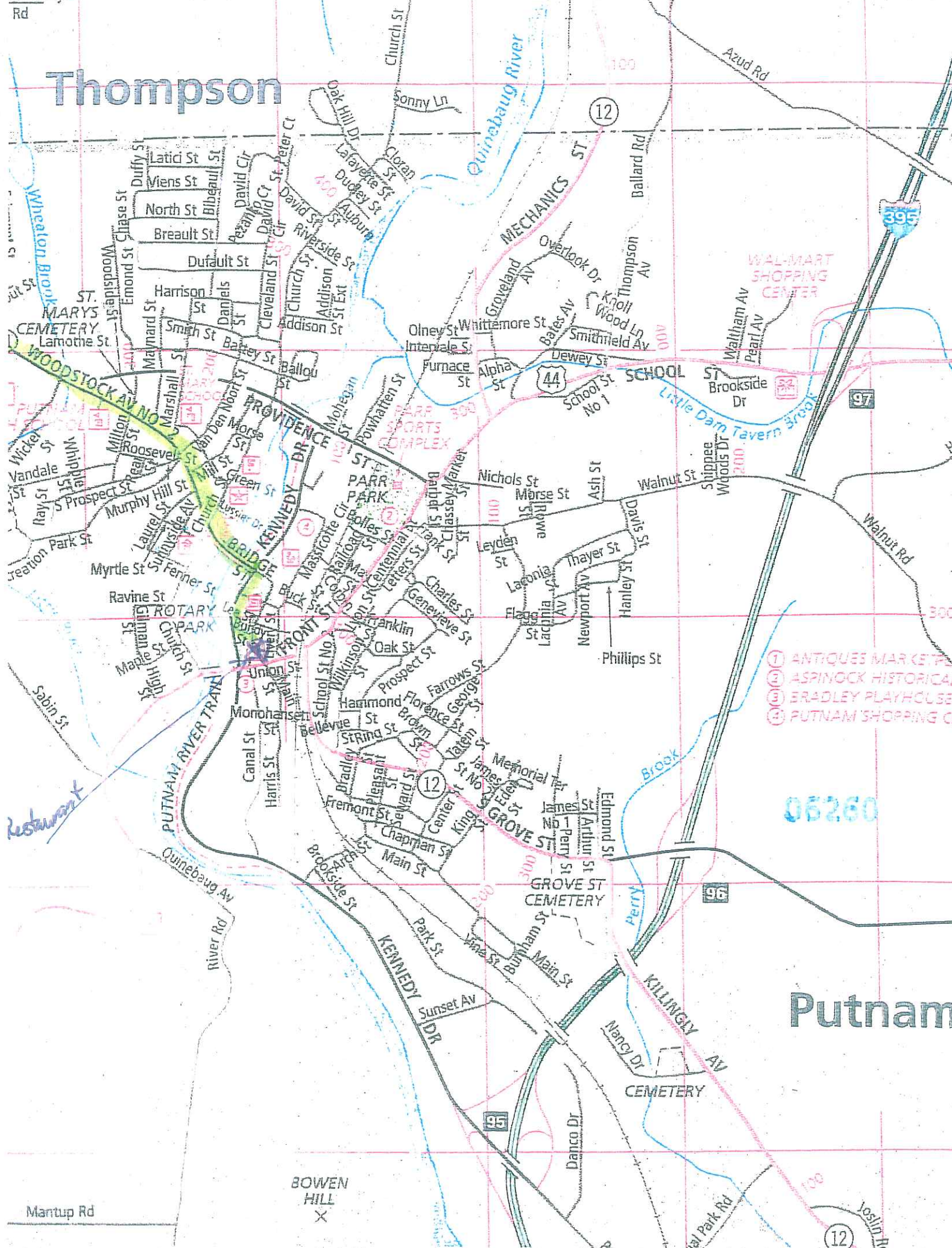
**TO: The Courthouse Bar & Grille – 121 Main Street, Putnam
From Hearing Location (Woodstock Town Hall)**

Turn left (south) onto Norwich-Worcester Turnpike (Route 169).
Proceed about 0.7 miles on Route 169.
Continue straight onto Route 169 / 171.
Continue straight / slight left onto Route 171 for about 2.7 miles.
Route 171 becomes Bridge Street.
Cross Quinebaug River via Bridge Street (Route 171).
Take first right onto Kennedy Drive.
Proceed on Kennedy Drive for about 0.1 miles.
Turn left onto Bundy Street.
Take slight right onto Main Street.
The Courthouse Bar & Grille Restaurant is located at 121 Main Street, Putnam.

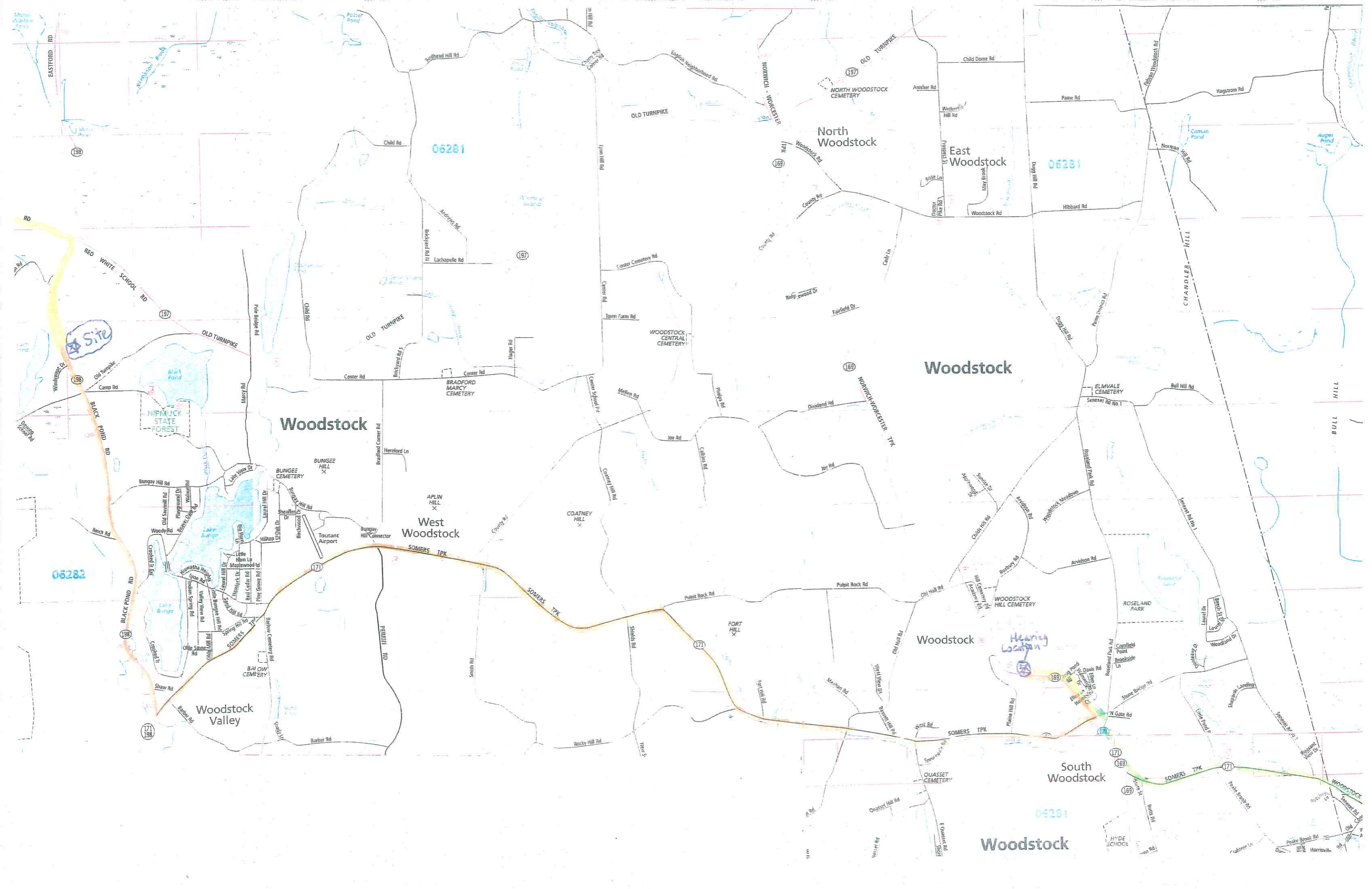
