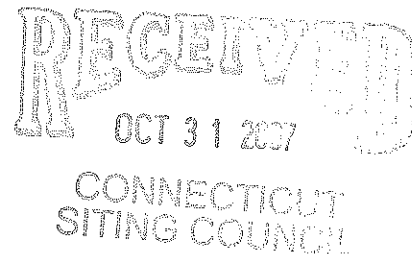

LEGAL NOTICE

Notice is hereby given, pursuant to Section 16-50(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about October 26, 2007, by Celco Partnership d/b/a Verizon Wireless ("Celco" or the "Applicant"). The Application proposes the installation of a wireless telecommunications facility in the Town of Woodstock, Connecticut. The installation would consist of a 100' x 100' leased area within a 53.6-acre parcel off Route 198, north of Old Turnpike Road. At this site, Celco proposes to construct a 140-foot monopole tower. Access to the site will extend from Route 198, a distance of approximately 1,776 feet, to the cell site. Celco will also install a new 12' x 30' shelter located near the base of the tower to house its radio equipment and an emergency back-up generator. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50g et. seq.

On the day selected for the Siting Council public hearing on this proposal, Celco will fly a balloon at the height of the proposed tower described above, between the hours of 8:00 a.m. and 5:00 p.m. Interested parties and residents of the Town of Woodstock are invited to review the Application during normal business hours at any of the following offices:
