Travel via Route 59 North to Route 25 in Monroe

Turn left onto Route 25 North

Travel via Route 25 North through Monroe, Newtown, and into Brookfield

Turn right onto Federal Road/Route 7

Travel via Route 7 for approximately 20 miles into Kent

Turn right onto Route 341/Maple Street

The site will be on the right (approx. 0.3 miles after turning onto Maple St.)

The proposed site is at the Town Transfer Station

#### To Proposed Site From the Milford area (Dr. Bell)

Travel via Route 15 South to exit 49 for Route 25 North

Travel via Route 25 North into Brookfield

Turn right onto Federal Road/Route 7

Travel via Route 7 for approximately 20 miles into Kent

Turn right onto Route 341/Maple Street
