Cellco Partnership d/b/a Verizon Wireless ("Cellco") will be submitting an application to the Connecticut Siting Council ("Council") on or about December 7, 2007, for approval of the construction of a telecommunications facility in the Town of New Milford, Connecticut.

The facility would consist of a new 150-foot self-supporting monopole tower and a 12' x 30' equipment shelter located on a 3.85 acre parcel at 359 Litchfield Road. The parcel is owned by the Northville Volunteer Fire Department, Inc. and is used as the Northville Fire Station. An on-site backup generator would also be installed inside Cellco's shelter. The tower would be designed to accommodate multiple carriers. Access to this site will extend from Big Bear Hill Road.

The location and other features of the proposed facility are subject to change under the provisions of Connecticut General Statutes § 16-50g et seq.

State law provides that owners of record of property which abuts a parcel on which the proposed facility may be located must receive notice of the submission of this application. This notice is directed to you either because you may be an abutting land owner or as a courtesy notice.


