

**LEGAL NOTICE**

Notice is hereby given, pursuant to Section 16-11(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on about February 1, 2008, by Cellco Partnership d/b/a Verizon Wireless ("Cellco" or the "Applicant"). The Application proposes the installation of a wireless telecommunications facility in the Town of Farmington, Connecticut. The installation would consist of a 100' x 100' leased area within a 9.9-acre parcel at 199 Town Farm Road. At this site, Cellco proposes to construct a 17-foot monopine tower. Access to the site will extend from Town Farm Road, a distance of approximately 580 feet, to the cell site. Cellco will also install a new 12' x 30' shelter located near the base of the tower to house its radio equipment and an emergency backup generator. A 1000 gallon propane tank will also be installed within the fenced compound. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50g et. seq.

On the day selected for the Siting Council public hearing on this proposal, Cellco will fly a balloon at the height of the proposed tower described above, between the hours of 8:00 a.m. and 5:00 p.m. Interested parties and residents of the Town of Farmington are invited to review the Application during normal business hours at any of the following offices:
