Cellco Partnership d/b/a Verizon Wireless (“Cellco”) will be submitting an application to the Connecticut Siting Council (“Council”) on or about February 22, 2008, for approval of the construction of a telecommunications facility at one of two locations in the North Grosvenordale section of the Town of Thompson, Connecticut.

The first proposed cell site location (“Site A”) would consist of a new 140-foot, self-supporting telecommunications tower and a 12’ x 30’ equipment shelter located on a 1.98 acre parcel at 347 Riverside Drive. This parcel is owned by Rene B. and Mary V. Santerre, Trustee and is the site of the D&R Masonry Supply Company. Cellco’s radio equipment and an on-site backup generator would also be installed inside Cellco’s shelter. The tower would be designed to accommodate multiple carriers. Access to Site A would extend from Riverside Drive.

The second proposed cell site location (“Site B”) would consist of a new 140-foot, self-supporting telecommunications tower and a 12’ x 30’ equipment shelter located on a 3.43 acre parcel at 407 Riverside Drive. The parcel is also owned by David F. Rogers and is used for residential purposes. A back-up generator would also be installed inside Cellco’s shelter. The tower would be designed to accommodate multiple carriers. Access to Site B would extend from Riverside Drive.

The location and other features of the proposed facility are subject to change under the provisions of Connecticut General Statutes § 16-50g et seq.


