#### From New Britain/Hartford Area

Follow Route 4 west through Farmington and Unionville to Route 179 north, towards Collinsville.

Follow Route 179 north to Route 44 in Canton.

Follow Route 44 west into Winsted.

Parking lot is to rear of building – access parking lot from Case Avenue or Elm Street.

### From Waterbury/Meriden Area

Follow Interstate 84 to Route 8 north in Waterbury.
