### **DIRECTIONS TO FIELD REVIEW – 165 Elmwood Hill Road, Putnam**

#### **From the Fairfield, Milford, Ansonia areas**

Travel via I-95 North to I-395 North (toward Plainfield/Norwich).  
Take exit 76 and merge onto I-395 North.  
Travel via I-395 North to Exit 97 (Route 44).  
Turn right onto Route 44 going east and follow ~2.4 miles to Munyan Road on left -  
at sign for Quaddick State Park.  
Turn left onto Munyan Road and follow to end.  
Turn left onto East Putnam Road and follow to stop sign.  
Turn right onto Elmwood Hill Road and follow uphill to site.

#### **From Hartford, Middletown, New Britain areas**

Travel I-91 to I-84 East.  
Travel I-84 east to Exit 69 (Route 74).  
Travel Route 74 East to Route 44.  
Travel Route 44 East through Pomfret and Putnam center.  
After I-395 overpass, follow Route 44 ~2.4 miles to Munyan Road on left - at sign for  
Quaddick State Park.  
Turn left onto Munyan Road and follow to end.  
Turn left onto East Putnam Road and follow to stop sign.  
Turn right onto Elmwood Hill Road and follow uphill to site.

### **From the North Stonington area**

Travel west on Route 2 to Route 164 North.

Follow Route 164 north to I-395 North.

Travel via I-395 North to Exit 97 (Route 44).

Turn right onto Route 44 going east and follow ~2.4 miles to Munyan Road on left - at sign for Quaddick State Park.

Turn left onto Munyan Road and follow to end.

Turn left onto East Putnam Road and follow to stop sign.

Turn right onto Elmwood Hill Road and follow uphill to site.

### **DIRECTIONS TO HEARING LOCATION – Putnam Middle School, 35 Wicker Street, Putnam.**

#### **From Site**

Follow Elmwood Hill Road downhill to East Putnam Road.

Turn left onto East Putnam Road.

Turn right onto Munyan Road.

Turn right onto Route 44, going west.

Follow Route 44 west to Route 171 west (Providence Street).

Follow Route 171 west ~0.8 mile to Wicker Street on left (at traffic light after cemetery).

Follow Wicker Street to first right - follow driveway past first building to parking lot.

#### **From the Fairfield, Milford, Ansonia area**

Travel via I-95 North to I-395 North (toward Plainfield/Norwich).

Take exit 76 and merge onto I-395 North.

Travel via I-395 North to Exit 97 (Route 44).

Take left off exit, following Route 44 west to Route 171 (Providence Street).

Follow Route 171 west ~0.8 mile to Wicker Street on left (at traffic light after cemetery).

Follow Wicker Street to first right - follow driveway past first building to parking lot.

#### **From Hartford, Middletown, New Britain areas**

Travel I-91 to I-84 East.

Travel I-84 east to Exit 69 (Route 74).

Travel Route 74 East to Route 44.

Travel Route 44 East through Pomfret.

After Day Kimball Hospital, turn left onto Sabin Street (bottom of hill).

Turn right onto Recreation Park Street.

Take first left onto Wicker Street (Keech Street).

Follow to school entrance on left, go past first building to Auditorium entrance.

**To Restaurant** – Courthouse Grill, 121 Main Street, Putnam

From Middle School, turn left onto Wicker Street.

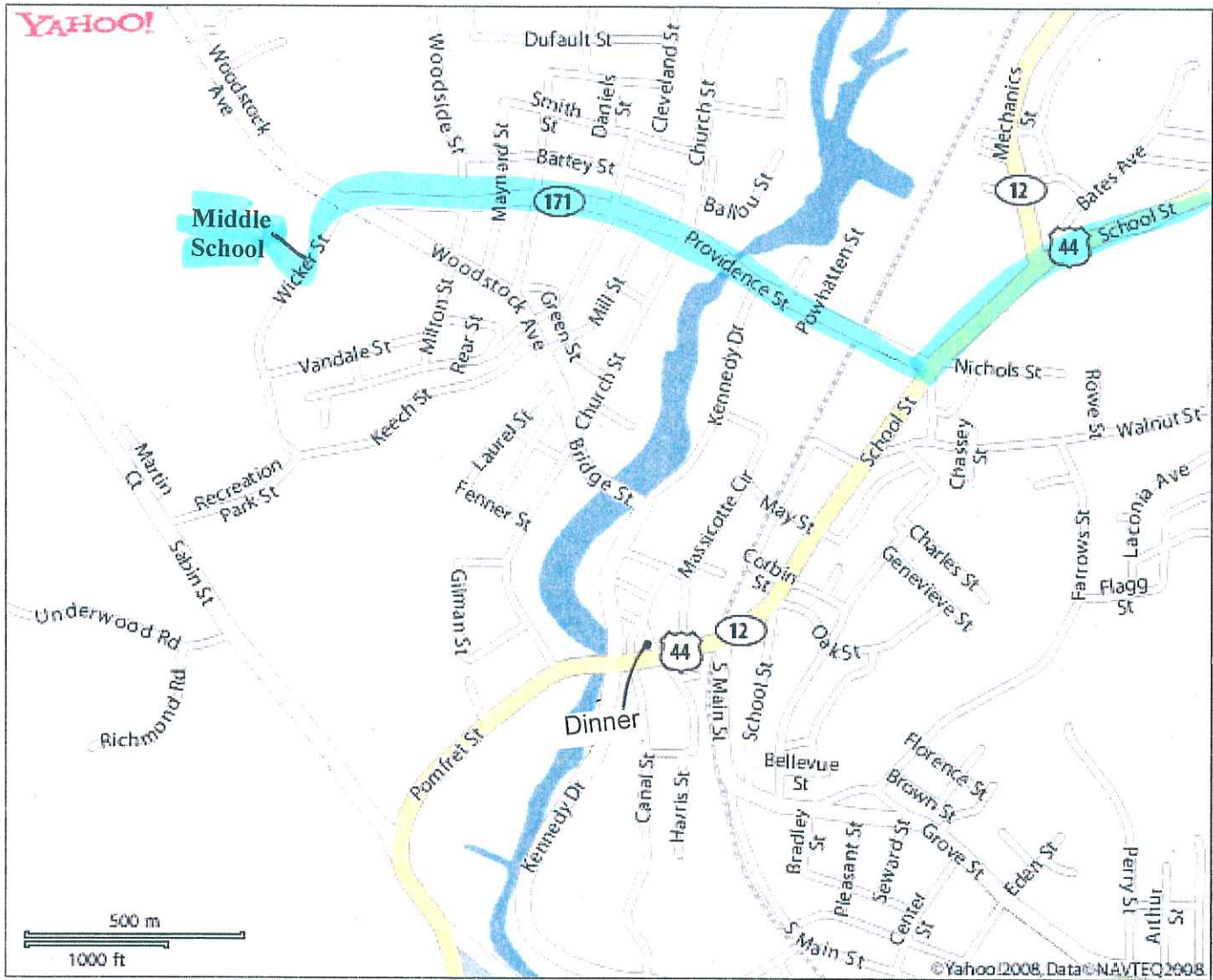
Turn right onto Woodstock Ave.

Cross river and go straight to stop sign.

Turn right and go straight at second stop sign.

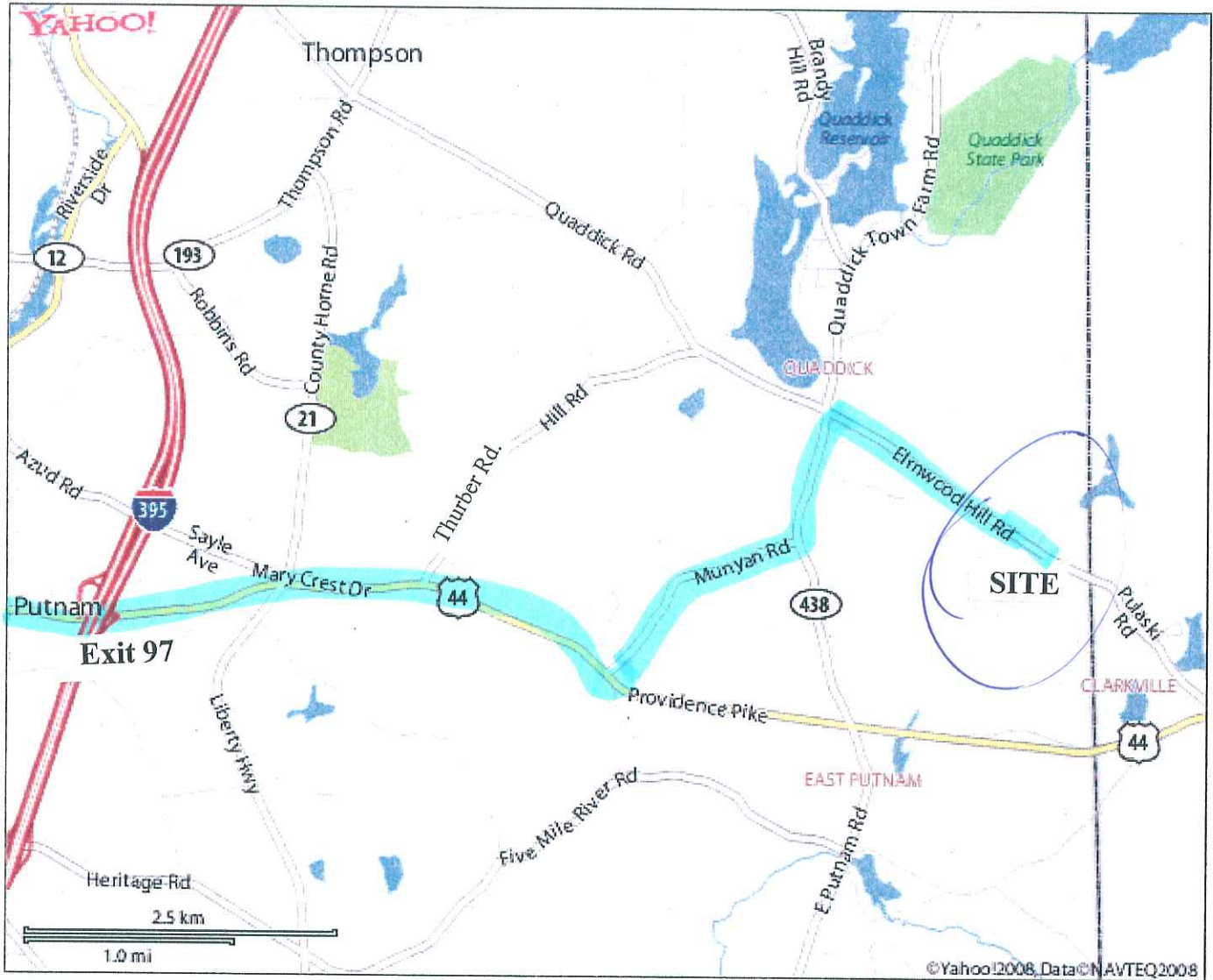
Park in municipal lot to left or park in street up the road.
