Turn right onto Green Hill Road (at traffic light).
Proceed to stop sign.
Turn right onto Ridge Road.
Proceed to site at end of road.

Via Interstate 95 – (Milford – New Haven)

Follow I-95 north to Exit 61 for Route 79.
Follow Route 79 north to Green Hill Road (at traffic light).
Turn left onto Green Hill Road.
Proceed to stop sign.
Turn right onto Ridge Road.
Proceed to site at end of road.

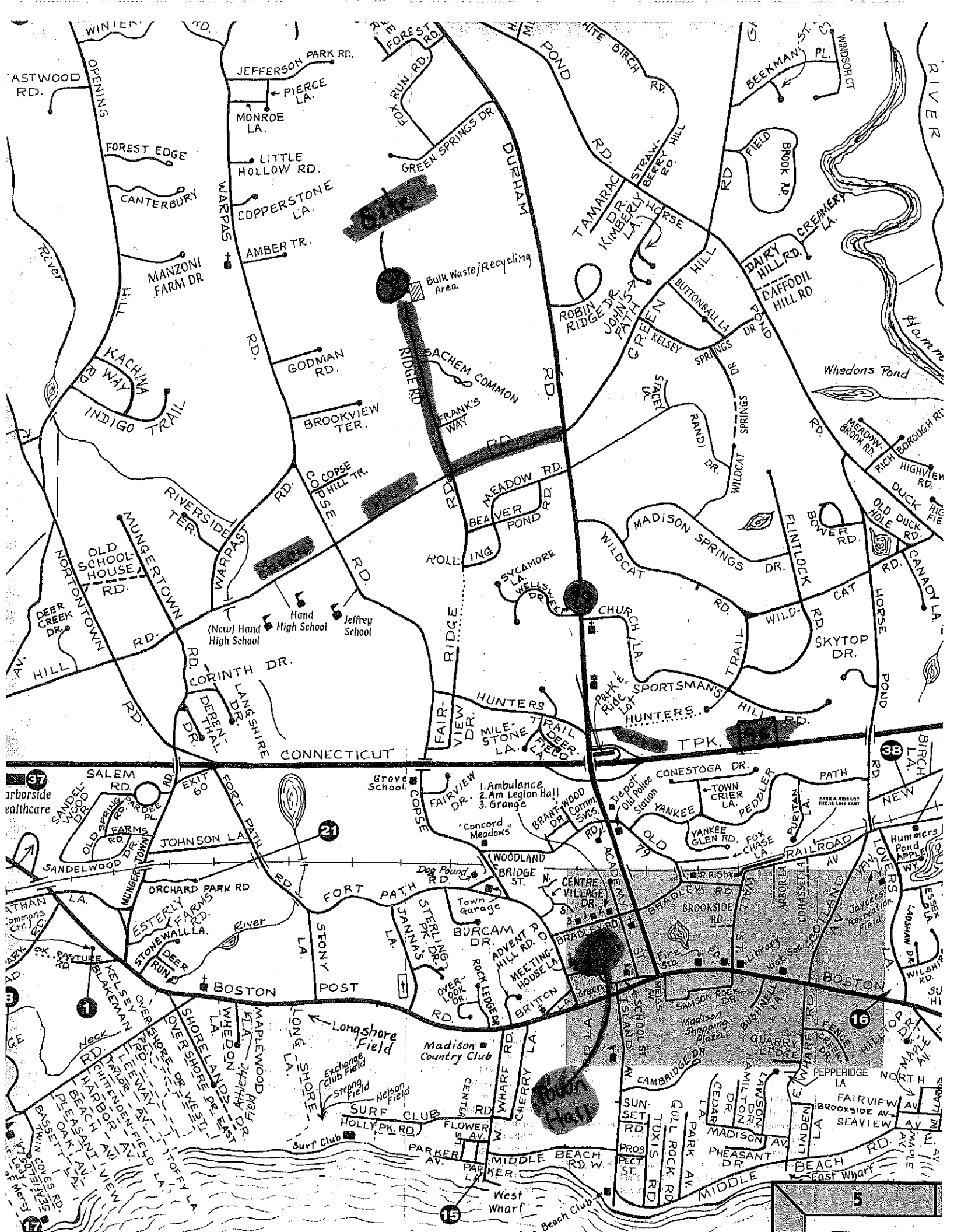
Proceed down Ridge Road to stop sign.
