

TO FIELD REVIEW – 325 Waterford Parkway North, Waterford

Via Interstate 91 and Route 9:

Proceed on I-91.

Take Exit 22 (Route 9 South) to Route 9 South.

Take Route 9 South to Interstate 95 North.

Take Exit 75 (toward Waterford) off of I-95 North.

At end of the exit ramp, bear right onto Boston Post Road (Route 1).

Proceed on Route 1 for about 0.4 miles.

Turn left onto Oil Mill Road.

Proceed on Oil Mill Road for about 0.5 miles.

Turn right onto Waterford Parkway North.

The site is directly on the left and parking is on your right.

Via Interstate 95 North (i.e. east) (from Southwest Connecticut):

Proceed on I-95 North.

Take Exit 75 (toward Waterford) off of I-95 North.

At end of the exit ramp, bear right onto Boston Post Road (Route 1).

Proceed on Route 1 for about 0.4 miles.

Turn left onto Oil Mill Road.

Proceed on Oil Mill Road for about 0.5 miles.

Turn right onto Waterford Parkway North.

The site is directly on the left and parking is on your right.

Via Interstate 95 South (i.e. west) (from Southeast Connecticut):

Proceed on I-95 South.

Take Exit 80 (Oil Mill Road) off of I-95 South.

At the end of the exit ramp, turn left onto Waterford Parkway North.

The site is directly on the right and parking is on your left.

Via Route 2 East (from Hartford area):

Proceed on Route 2 East.

Take Exit 19 (Route 11 South) off of Route 2 East.

Proceed on Route 11 South for 7.4 miles.

Take Exit 4 (Route 82) off of Route 11 South.

At the end of the exit ramp, turn left onto East Haddam Road (Route 82).

Proceed on Route 82 for 1.2 miles.

Turn right onto New London Road (Route 85 South).

Continue on Route 85 for 7.7 miles.

Turn right onto Way Hill Road.

Proceed on Way Hill Road for 0.5 miles.

Turn left onto Oil Mill Road.

Proceed on Oil Mill Road for 1.4 miles.

Turn left onto Waterford Parkway (North).

The site is on the left and parking is on the right.

From Site:

Turn right out of the parking lot and proceed (east) on Waterford Parkway

North.

Proceed on Waterford Parkway North for 1.4 miles.

Turn right onto Cross Road.

Proceed on Cross Road for 1.0 miles.

Turn left onto the Boston Post Road (Route 1).

Proceed on Route 1 for 2.0 miles.

Turn right onto Rope Ferry Road (Route 156).

The Waterford Town Hall is on the right, across the street from Waterford High School.

Via Interstate 91 and Route 9:

Proceed on I-91.

Take I-91 to Exit 22 (Route 9 South).

Proceed on Route 9 South.

Take Route 9 South to Interstate 95 North.

Proceed on Interstate 95 North.

Take Exit 75 (Route 1) off of I-95 North.

At the end of the exit ramp, turn right onto Boston Post Road (Route 1).

Proceed on Route 1 for 4.2 miles

Turn right onto Rope Ferry Road (Route 156).

Proceed on Route 156 for 0.1 miles.

The Waterford Town Hall is on the right, across the street from Waterford High School.

Via Interstate 95 South (i.e. west) (from Southeast Connecticut):

Proceed on I-95 South.

Take Exit 81 (Cross Road) off of I-95 South.

Turn left onto Parkway North.

Proceed on Parkway North for 0.6 miles.

Turn left onto Cross Road.

Proceed 1.0 miles on Cross Road.

Turn left onto Boston Post Road (Route 1).

Proceed on Route 1 for 2.0 miles.

Turn right onto Rope Ferry Road (Route 156).

The Waterford Town Hall is on the right, across the street from Waterford High School.

Via Interstate 95 North (i.e. east) (from Southwest Connecticut):

Proceed on Interstate 95 North.

Take Exit 75 (Route 1) off of I-95 North.

At the end of the exit ramp, turn right onto Boston Post Road (Route 1).

Proceed on Route 1 for 4.2 miles

Turn right onto Rope Ferry Road (Route 156).

Proceed on Route 156 for 0.1 miles.

The Waterford Town Hall is on the right, across the street from Waterford High School.

Via Route 2 East (from Hartford area):

Proceed on Route 2 East.

Take Exit 19 (Route 11 South) off of Route 2 East.

Proceed on Route 11 South for 7.4 miles.

Take Exit 4 (Route 82) off of Route 11 South.

At the end of the exit ramp, turn left onto East Haddam Road (Route 82).

Proceed on Route 82 for 1.2 miles.

Turn right onto New London Road (Route 85 South).

Proceed on Route 85 South for 8.7 miles.

Turn right onto Cross Road.

Proceed on Cross Road for 2.2 miles.

Turn left onto Boston Post Road (Route 1).

Proceed on Route 1 for 2 miles.

Turn right onto Rope Ferry Road (Route 156).

The Waterford Town Hall hearing location is across the street from the Waterford High School.

**TO: JR's Shack – 131 Boston Post Road, Waterford
From Hearing Location (Waterford Town Hall)**

Turn left onto Rope Ferry Road (Route 156).

Proceed on Route 156 for 0.1 miles.

Turn right onto Boston Post Road (Route 1).

Proceed 0.1 miles on Boston Post Road (Route 1).

JR's Shack Restaurant is located at 131 Boston Post Road (Route 1), at the intersection of Route 1 and Clark Lane.
