
In response to your request, at the September 23, 2008 hearing the Connecticut Siting Council (Council) granted you intervenor status in Docket No. 364.

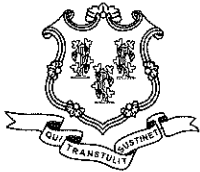
