

EXPEDITED REQUEST FOR CONTINUANCE

The City of Danbury hereby formally and respectfully requests that this Council grant the City of Danbury, a party in the above referenced docket, a continuance of the scheduled hearing of October 28, 2008, of a minimum of thirty (30) days due to the unanticipated necessity of obtaining the services of a new professional and technical expert to advise it on the subject Application defense. The City's previous expert and the City of Danbury have encountered certain irreconcilable differences including the inability of the parties to agree on the level and substance of testimony that is needed, as well as the scope of such testimony, such that further joint participation in this matter is not possible. The City of Danbury is in the process of aggressively securing new services to represent the technical interests in this case. As the field of cell tower experts is known to be a narrow range, there is some uncertainty regarding the time frame within which Danbury can secure these new services. Therefore, we ask that the Council be as liberal as reasonably possible with regard to a continuance granted.
