## **Objection to Administrative Notice of Docket Number 315**

The City of Danbury hereby objects to the applicant's motion for the Siting Council to take administrative notice of the findings of fact contained in Docket Number 315. The findings of fact from Docket Number 315, dated September 28, 2006, pertain to an application filed by Optasite, Inc and New Cingular Wireless PCS, LLC for a certificate of environmental compatibility and public need for the construction, maintenance and operation of a telecommunications facility located at 29 Bogus Hill Road in New Fairfield. The City of Danbury respectfully submits that the findings of fact and the ultimate use of a facility are immaterial and unrelated to the present application, as the site currently under consideration does not hand off to the facility located at Bogus Hill. The site that is currently under consideration and the Bogus Hill facility are not interconnected in any way.

Wherefore, the City of Danbury respectfully requests that its objection be sustained and that the Siting Council decline to take administrative notice of the findings of fact from Docket Number 315.
