REQUEST FOR EXTENSION OF TIME

The City of Danbury ("City"), a party to this proceeding pursuant to the Siting Council's ("Council") order of August 28, 2008, requests an extension of time of thirty days after the entry of the final judgment on the pending administrative appeal from the Council's decision in this application (Docket No. HHB-CV-09-4021287) to provide comment and/or objections to the applicant's Development & Management Plan, dated July 31, 2009 and received August 3, 2009. In the alternative, the City requests an extension of time of thirty days after the record in the administrative appeal is returned to the Court.

The City requests this extension of time because if the trial court modifies or reverses the Siting Council's Decision, it would render moot the substantial issues
