2. Also, and more specifically, is the disclosed rental amount for the subject site "*at the market*" rate for a facility or facilities identified in this Docket? How is such "*market rate*" determined by Optasite or its agents/partners?
3. Finally, is Optasite willing to pay "*market*" or a higher rate for an alternative site that may be available?
