At a public meeting of the Connecticut Siting Council held on December 4, 2008, the Connecticut Siting Council (Council) considered and denied the City of Danbury's request for an additional balloon float in the above mentioned proceeding.

The record reflects that a balloon float was conducted during the field review on September 9, 2008 in the presence of the Council, parties and intervenors. In addition to the field data gathered from the balloon float, the report document prepared by Vanasse Hangen Brustlin, Inc. (VHB) contains a comprehensive post-construction visibility analysis including seasonal "leaf off" conditions. Therefore, the Council has concluded that an additional balloon float is unnecessary.

The continuation of this hearing will proceed on evidentiary matters at 11:00 a.m. on Monday, December 8, 2008, at the Council's Office, 10 Franklin Square, New Britain, Connecticut in Hearing Room 1.
