

Notice is hereby given, pursuant to Section 16-50i(b) of the Connecticut General Statutes and Regulations pertaining thereto, of an Application to be submitted to the Connecticut Siting Council ("Council") on or about August 25, 2008, by Cellco Partnership d/b/a Verizon Wireless ("Cellco" or the "Applicant"). The Application proposes the installation of a wireless telecommunications facility in the Town of Willington, Connecticut. The facility would be located in the center of a 22 acre parcel at 343 Daleville Road on land owned by Muriel Kreuzscher. At this site, Cellco proposes to construct a 100-foot tower and install a 12' x 30' shelter near the base of the tower to house its radio equipment and a back-up generator. Vehicular and utility access to site would extend from Daleville Road. The location and other features of the proposed facility are subject to change under provisions of Connecticut General Statutes § 16-50g et seq.
