Please be advised that the Connecticut Siting Council (Council) has no record of the Certificate Holder submitting a Development and Management Plan in accordance with Condition 2 of the Council's February 19, 2009 Decision and Order for the above-referenced project. Council records indicate that the construction deadline for this project was August 17, 2013 after the Council granted three extensions of time for construction. For your convenience, the third letter from the Council granting an extension of time for construction dated July 26, 2012 is enclosed. Therefore, the Certificate for this project has expired.

If the Certificate Holder decides to pursue the Sterling Road site in the future, such a request will need to be submitted as a new application that must follow the applicable statutory and regulatory requirements for a new application for a Certificate.
