and Public Need for the construction, maintenance and operation of a telecommunications facility located off Sterling Road (Route 14), Plainfield, Connecticut.

I. Introduction

This application is from Cellco Partnership d/b/a Verizon Wreless for the construction, maintenance, and operation of a telecommunications facility and associated equipment in the Mosup section of the Town of Plainfield, Connecticut.

Cellco's proposed facility would be located on a privately owned 32.2 acre parcel off of Sterling Road (Route 14) and would consist of a 160-foot monopole tower within a 50-foot by 75-foot compound.

II. Technical

The application includes relevant maps, descriptions of the proposed site, costs, a description of the environmental effects of the proposed construction, and health and safety information. The application meets statutory technical requirements for processing the application. Council staff believes additional information can be obtained through pre-hearing interrogatories. This project would not require an outside consultant.

III. Administrative Review

The applicant has stated that all service and filing requirements pursuant to General Statutes § 16-50<u>l</u> (b) have been fulfilled. The applicant stated that notice to the general public was published in the Norwich Bulletin.

IV. Procedural
