RE: **DOCKET NO. 370A_MR** - The Connecticut Light & Power Company Certificate of Environmental Compatibility and Public Need for the Manchester Substation to Meekville Junction Circuit Separation Project in Manchester, Connecticut. **Request to temporarily change hours of construction.**

Dear Mr. Carberry:

In response to your email of May 4, 2012, requesting Connecticut Siting Council (Council) staff approval for three change of work hour requests. The requests include 1.) approval to work at Manchester Substation 14 hours per day from May 4, 2012 through May 15, 2012 and 24 hours per day within the control house for the same time period; 2.) approval to work up to 14 hours per day, six days per week within the 345-kV switchyard at Manchester Substation from now until June 2, and on Sunday, June 3, 2012; and 3.) approval to perform conductor sagging and fiber optic cable work between structures 3708 and 3720 on Sunday, May 13, 2012 and between structures 3701 and 3710 on Sunday, May 20, 2012. CL&P has asserted that this work is necessary to prepare and keep the construction schedule in synch with planned line outages. Please be advised that by this writing Council staff hereby approves the proposed temporary extension of work hours. This approval is contingent upon a response of no objection from the Town of Manchester.

Any changes to the D&M Plan require advance Council notification and approval. Please be advised that deviations from this plan are enforceable under the provisions of the Connecticut General Statutes § 16-50u.

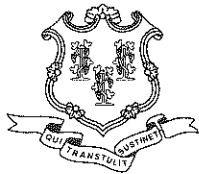
