**DOCKET 370A** - The Connecticut Light & Power Company application for Certificates of Environmental Compatibility and Public Need for the Connecticut Valley Electric Transmission Reliability Projects which consist of (1) The Connecticut portion of the Greater Springfield Reliability Project that traverses the municipalities of Bloomfield, East Granby, and Suffield, or potentially including an alternate portion that traverses the municipalities of Suffield and Enfield, terminating at the North Bloomfield Substation; and (2) the Manchester Substation to Meekville Junction Circuit Separation Project in Manchester,

Connecticut.

**DOCKET 370B** - NRG Energy, Inc. application pursuant to C.G.S. §16-50*l*(a)(3) for consideration of a 530 MW combined cycle generating plant in Meriden, Connecticut.

As you are aware, one of the above-captioned pending Connecticut Siting Council (Council) dockets concerns a project situated in the City of Meriden. Please let us know by May 22, 2009 should you have any concerns in his so serving.
