RE: **DOCKET NO. 370** - The Connecticut Light & Power Company Certificate of Environmental Compatibility and Public Need for the Connecticut portion of the Greater Springfield Reliability Project that traverses the municipalities of Bloomfield, East Granby, and Suffield, terminating at the North Bloomfield Substation.

Dear Mr. Rebenske:

At a public meeting of the Connecticut Siting Council held on April 28, 2011, the Connecticut Siting Council (Council) denied your Request to Reopen, dated April 11, 2011 on the basis that changed conditions as defined under Connecticut General Statutes § 4-181a(b) do not exist in this request to warrant reopening of the final decision in this matter. The request to reopen specifically relates to drainage during construction, which is directly addressed in the Development and Management Plan (D&M Plan).

The Council approved the "Drainage Analysis for the Newgate/Phelps Road and the Hatchett Hill Road Areas" on February 8, 2011 as a revision to that originally proposed in the Connecticut portion of the Greater Springfield Reliability Project D&M Plan. The revised drainage plan was intended to add control measures to the Newgate/Phelps Road Area and Hatchett Hill Road Area to address town and resident drainage concerns in the area. Prior to submitting the revision to the drainage plan, CL&P consulted with the Town Engineer of East Granby and individual landowners to include additional control measures.

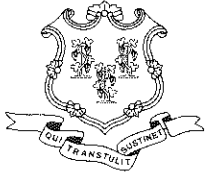
