



Hartford - Avon CT - HFCT1526B at 77 feet AGL




Hartford - Avon CT - Composite Coverage with HFCT1526B at 77 feet AGL




Proposed Site (224 Lovely Street) at 67 feet AGL

Hartford - Avon CT - HFCT1526B at 67 feet AGL




Hartford - Avon CT - Composite Coverage with HFCT1526B at 67 feet AGL




Huckleberry Recreation Area at 247 feet AGL

Hartford - Avon CT - Huckleberry Recreation Area Isolated at 247 feet AGL




Hartford - Avon CT - Composite Coverage with Huckleberry Recreation Area at 247 feet AGL




Huckleberry Recreation Area at 197 feet AGL

Hartford - Avon CT - Huckleberry Recreation Area Isolated at 197 feet AGL




Hartford - Avon CT - Composite Coverage with Huckleberry Recreation Area at 197 feet AGL




Huckleberry Recreation Area at 137 feet AGL


Hartford - Avon CT - Huckleberry Recreation Area Isolated at 137 feet AGL
