Finding of Fact 44(c): Repeated phone calls and e-mails to ~~the owners of this property~~ School representatives were never returned.

Finding of Fact 44(d): Repeated phone calls and e-mails to ~~the owners of this property~~ School representatives were never returned.

Finding of Fact 44(o): This is an approximately 13.1-acre parcel at ~~210~~ 219 Cider Brook Road in Avon. Wetlands on this property would make finding a suitable location for Cellco's facility difficult.


