
In response to your request, at the May 14, 2009 hearing the Connecticut Siting Council (Council) granted you party status in Docket No. 274.

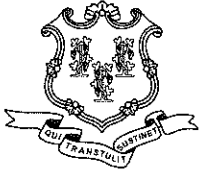
