TO FIELD REVIEW:

From Waterbury

Follow Interstate 84 west to Exit 17, Route 64.

Follow Route 64 west to Route 6.

Turn right onto Route 6 east.

Follow Route 6 east through Woodbury Center to Route 47 at light. Turn left.

Follow Route 47 north through Hotchkissville village and past Route 132.

Parking area for carpool is 0.5 mile past Route 132 on the left.

Park in dirt lot at corner of Hoop Pole Road/ Paper Mill Road. Lot is just past green, one-story building on left.

From Bridgeport Area

Follow Route 8 north to Interstate 84 west in Waterbury. Follow directions from Waterbury above.

From New Haven, Derby Areas

In New Haven, follow Interstate 95 to Route 34 west.

Follow Route 34 west into Derby.

From Derby, follow Route 8 north to Interstate 84 west in Waterbury.

Follow directions from Waterbury above.

TO HEARING:

From Site

Follow Route 47 back to Route 6 in Woodbury Center.

Turn left onto Route 6 going east (at light).

Turn right onto Middle Turnpike (signs for high school).

Turn left onto Minortown Road.

School is to left.

Auditorium is building to left.

From Waterbury

Follow Interstate 84 west to Exit 17, Route 64.

Follow Route 64 west to Route 6.

Follow Route 6 east through Woodbury Center and past Route 47 to Middle Turnpike on right.

Follow Middle Turnpike and turn left onto Minortown Road.

School is to left.

Auditorium is building to left.

TO DINNER: Curtis House

From school, turn right onto Minortown Road.

Turn right onto Middle Turnpike.

At stop sign, turn left onto Route 6 going west.

Follow through Woodbury Center.

Curtis House is old, white wood frame building on right at 506 Main Street South.
