TO FIELD REVIEW – 24 Dinglebrook Lane, Newtown

Via Interstate 84 West:

Proceed on I-84 West.

Take Exit 10 (Route 6 – Newtown / Sandy Hook) off of I-84 West.

Turn right onto Route 6 (Church Hill Road).

Proceed on Route 6 (Church Hill Road) for about 0.6 miles.

Turn right onto The Boulevard.

Proceed on The Boulevard for about 1.3 miles.

The Boulevard becomes Hanover Road.

Proceed on Hanover Road for about 0.5 miles.

Bear left to stay on Hanover Road.

Continue on Hanover Road for about 1.8 miles.

Hanover Road becomes Dinglebrook Lane.

Proceed straight on Dinglebrook Lane for about 0.5 miles.

The site is on the right at 24 Dinglebrook Lane, adjacent to the applicant's sign.

Via Interstate 95 and/or Route 8 / 25 North (from Fairfield County area)

Take Interstate 95 to Route 8 / 25 North.

Proceed on Route 8 North.

Continue onto Route 25 North.

Follow Route 25 to the Newtown Town Line.

Proceed on Route 25 for about 5.2 miles.

Bear right onto Hanover Road.

Proceed on Hanover Road for about 1.1 miles.

Bear left to stay on Hanover Road.

Continue on Hanover Road for about 2.3 miles.

Continue straight onto Dinglebrook Lane.

Proceed on Dinglebrook Lane for about 0.5 miles.

The site is on the right at 24 Dinglebrook Lane, adjacent to the applicant's sign.

Via Interstate 91:

Take Interstate 91 to the I-84 Interchange.

Bear right onto Hanover Road. (There is no street sign. There is only a Pond Brook sign pointing right.)

Proceed on Hanover Road for about 2.3 miles.

Bear right onto Hanover Road (no sign) and cross a bridge.

Turn left onto Hanover Road.

Continue on Hanover Road for about 1.0 miles.

Bear left onto Route 6 / 25 (Main Street).

Continue on Main Street for about 0.2 miles.

The Town Hall is located on the right at 45 Main Street.

Via Interstate 84 West:

Proceed on I-84 West.

Take Exit 10 (Route 6 – Newtown / Sandy Hook) off of I-84 West.

Turn right onto Route 6 (Church Hill Road).

Proceed on Church Hill Road for about 1.1 miles.

Turn right onto Main Street (Route 6 / 25).

Proceed on Main Street for about 0.1 miles.

The Town Hall is located on the left at 45 Main Street.

Via Interstate 95 and/or Route 8 / 25 North (from Fairfield County area)

Take Interstate 95 to Route 8 / 25 North.

Proceed on Route 8 North.

Continue onto Route 25 North.

Follow Route 25 to the Newtown Town Line.

Proceed on Route 25 for about 5.0 miles.

The Town Hall is located on the left at 45 Main Street.

Via Interstate 91:

Take Interstate 91 to the I-84 Interchange.

Refer back to directions Via Interstate 84 West.

TO: Blue Colony Diner – 66 Church Hill Road, Newtown
From: Hearing Location (Edmond Town Hall)

Turn right onto Main Street.

Proceed on Main Street for about 0.1 miles.

Turn left onto Church Hill Road (Route 6).

Proceed on Church Hill Road for about 0.9 miles.

Blue Colony Diner is located at 66 Church Hill Road, Newtown.

Blue Colony Diner is on the right, directly before the I-84 East entrance ramp.

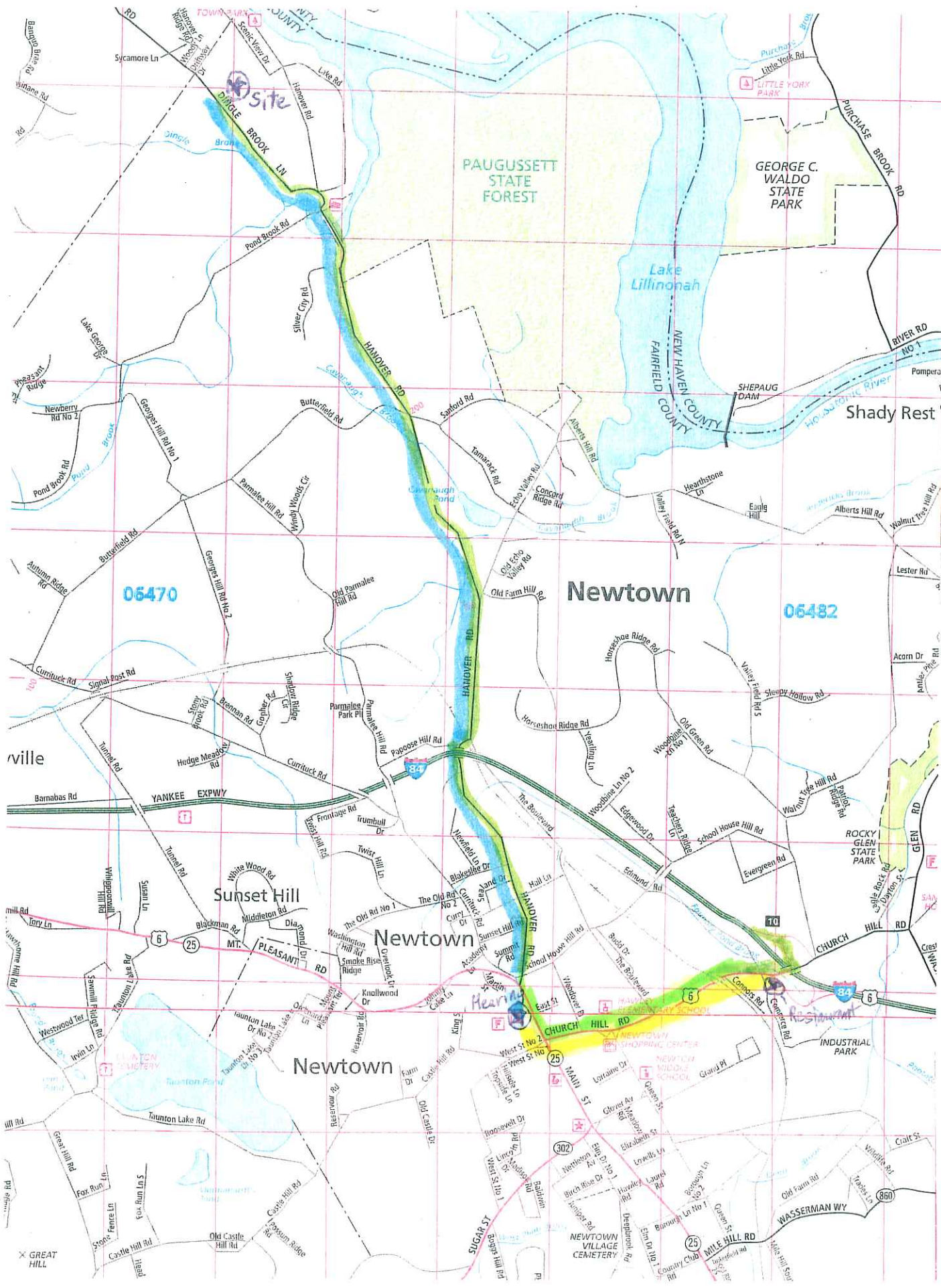

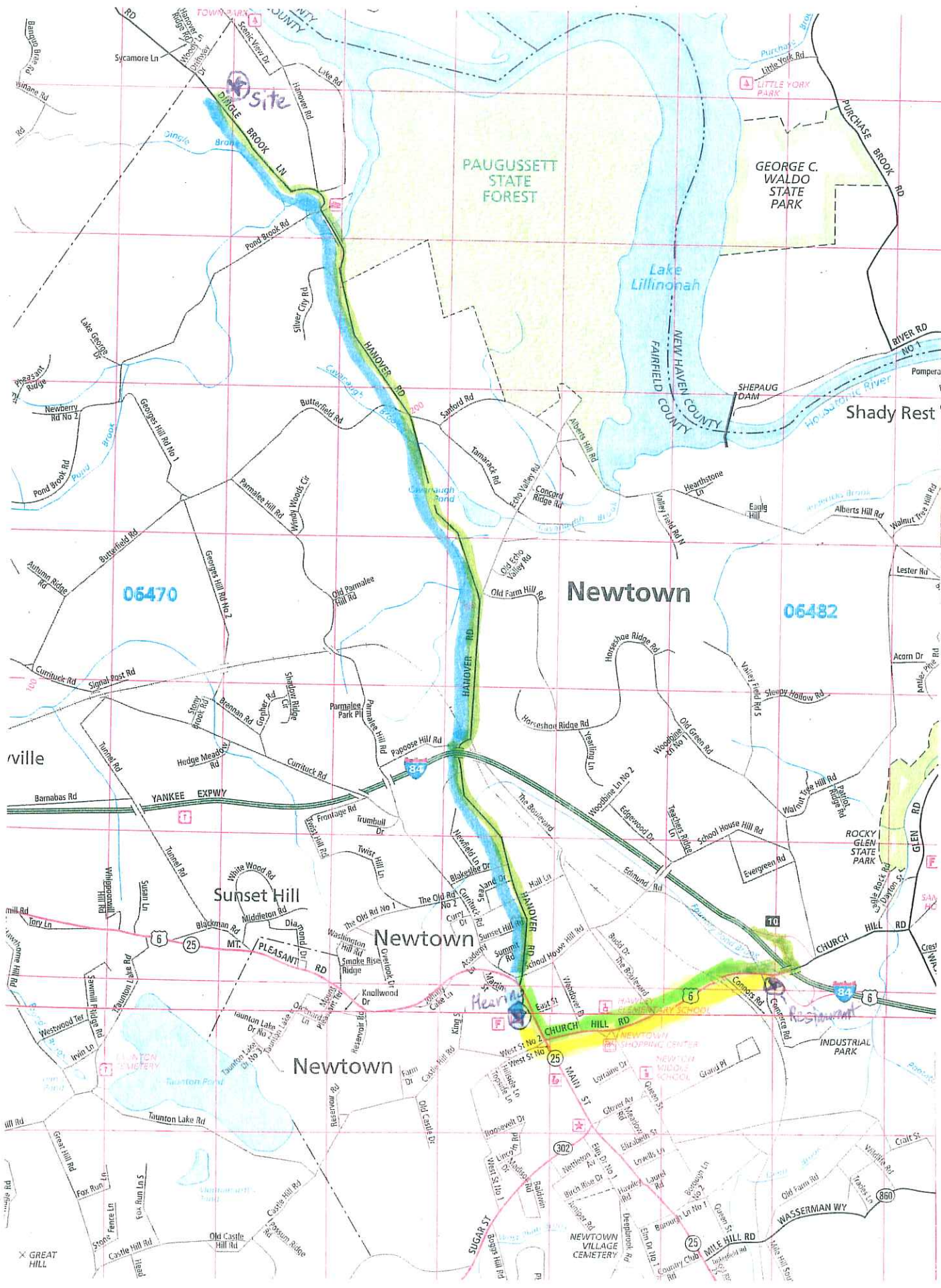
