The Council is in receipt of the Town of Washington (Town) Responses to Council's Interrogatories, received May 7, 2009. Thank you.

The Council notes that staff developed the interrogatories directed to the Town at the time when the Town, as represented by Mr. Lyon, existed singularly as a party to the proceeding (status granted April 7, 2009). However, subsequent to the mailing of the interrogatories, the Washington Conservation Commission, represented by Ms. Payne and Ms. Dupuis, applied for party status, (status granted April 23, 2009).

The Council recognizes that both the Town of Washington and the Washington Conservation Commission, as separate entities in this proceeding, may have collaborated in the development of the responses to the Town's interrogatories. Therefore, in order to best facilitate the orderly admittance of relevant exhibits, the Council requests that the Town of Washington, as represented by Mr. Lyon, and the Washington Conservation Commission, as represented by Ms. Payne and Ms. Dupuis, identify in writing which questions each party responded to – if in fact, there was joint participation in their development. Once this information is received, the Council will identify such responses on the hearing program in association with their appropriate party for admittance at the hearing.

Additionally, in accordance with Council procedures previously communicated under separate cover, the Council respectfully reminds you to please identify your panel of witnesses who will be swearing to these responses as well as other exhibits and pre-filed testimony. Submission of such information, as well as all pre-filed testimony, is due on May 14, 2009. Thank you.
