


SITE ACCESS MAP



A site survey was completed at the subject site in September of 2007. A requirement of the survey involved determining the location of all trees within the topographic survey area with a diameter at breast height of 6" or larger. As can be seen on the site access map, sixty-one trees with a diameter of 6" or larger are within the area of the proposed access road and compound. Therefore, sixty-one trees need to be removed to construct the facility.
