
Dear Mr. Macinnes:

This request will be placed on a future meeting agenda to adopt a schedule which will include a public hearing in your town. A copy of the agenda will be sent to you. Please note that this is a request for recertification of a previously approved site in which the certificate expired prior to completion of construction of the facility.

Pursuant to General Statutes § 16-50x(a), municipalities may provide to the Council location preferences or other criteria for the siting of telecommunications towers that are brought to the Siting Council for approval. The Council requests submission of these comments by April 20, 2009.
