### **TO FIELD REVIEW**

#### **From Route 8 (Waterbury/Bridgeport)**

Follow Route 8 to Exit 12.

From Exit follow Old Stratford Ave west towards Huntington. *(Turn left if coming from Bridgeport – turn right if coming from Waterbury).*

Go straight across Bridgeport Avenue (light) and go uphill, following Commerce Drive.

At stop sign at end of Commerce Drive, turn right onto Huntington Street.

Go approx. 0.9 miles and turn right onto Lane Street (at beginning of grass median - "Real Estate Two" on corner).

Follow Lane Street to traffic cone on left.

#### **From New Haven/Milford**

Follow I-95 to Exit 38 - Merritt Parkway Connector

Follow Merritt Parkway south to Exit 52, Route 8.

Follow Route 8 north.

See directions from Route 8 above.

### **TO CITY HALL FROM SITE**

From Lane Street, turn right onto Huntington Street and proceed to Route 108 (light).

Turn right at light onto Route 108 east.

Follow Route 108 downhill into Shelton.

Turn right onto Coram Avenue, following Route 108 north.

Go straight through traffic light (Center Street) and proceed uphill to Hill Street.

Turn right onto Hill Street, park along road, City Hall is on left.

### **TO CITY HALL FROM ROUTE 8**

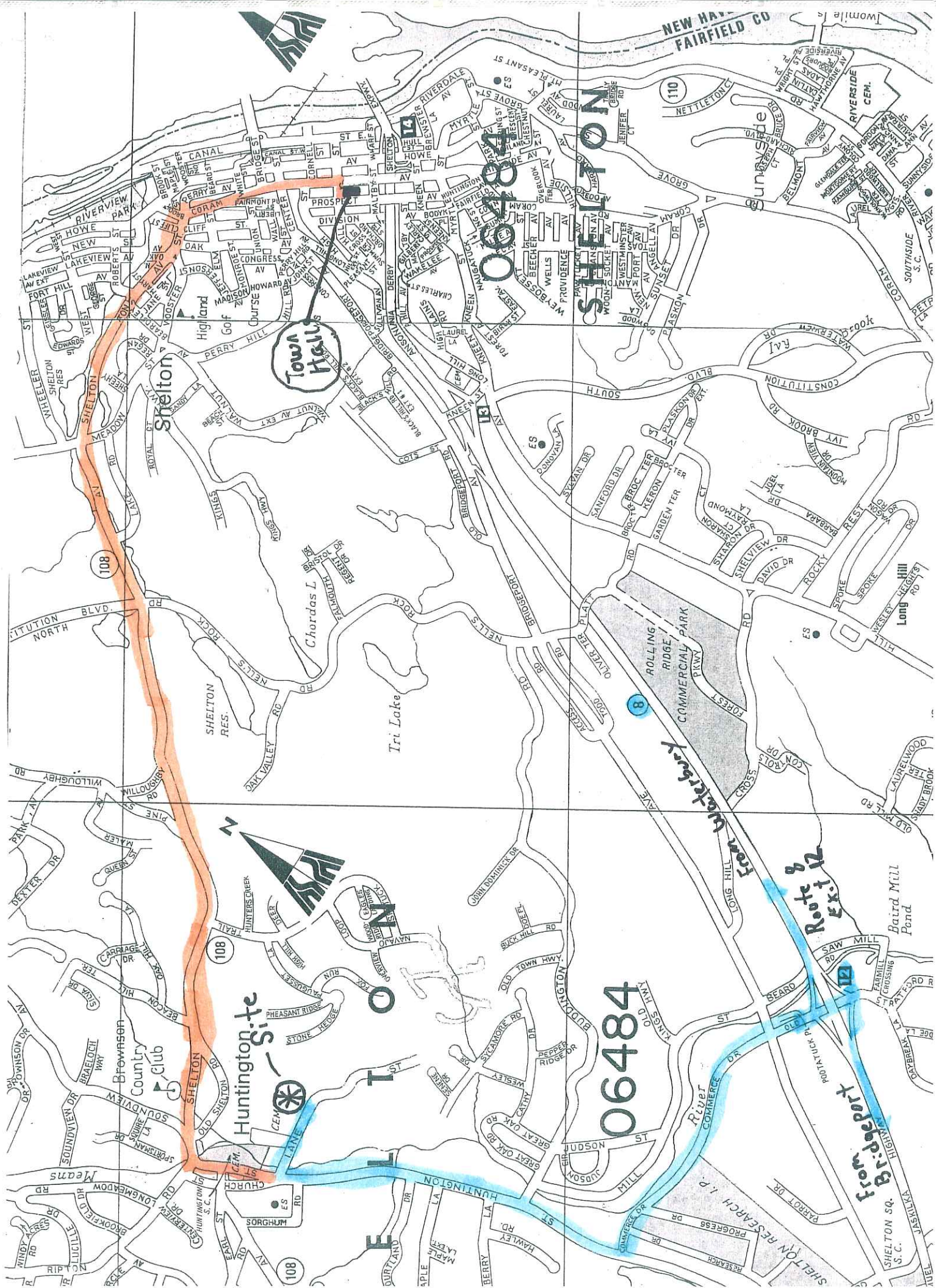
From Route 8, take exit 14.

At end of ramp, follow Route 110 north.

Go approx. 0.2 mile and turn left onto Hill Street ("Carroll's Home Improvement" on corner). City Hall is on left at top of hill.

## Directions to Restaurant

From City Hall, follow Hill Street downhill to Howe Avenue.  
Turn right onto Howe Avenue and follow to Route 8 north.  
From Route 8 north, take Exit 16 for Pershing Drive.  
At first light, take right and pull into driveway on right.
