Attached is a letter I received late last week from Attorney Douglas LoMonte, on behalf of Ms. Linda Cwanek, an abutting property owner to the Brownson Country Club property in the Huntington section of the City of Shelton. The letter references Ms. Cwanek's concern about the use of Old Pent Road to access the proposed cell site. This matter was discussed at length in Cellco's response to Council Interrogatory No. 7.

As discussed in Attorney LoMonte's letter, Ms. Cwanek is requesting that the Siting Council impose a condition on the approval of this application that specifically prohibits Cellco from accessing the cell site using Old Pent Road. As discussed at length in the Docket No. 382 application and in our response to Council Interrogatory No. 7, Cellco has no intention of using Old Pent Road to access the proposed cell site and does not object to Ms. Cwanek's request for a specific condition addressing this issue.


