

SIGN POSTING AFFIDAVIT
CONNECTICUT SITING COUNCIL DOCKET NO. 382

I, Dean Gustafson, being duly sworn, deposes and states that:

1. I am over eighteen years of age and I understand the obligations of a statement under oath.
2. I am a Senior Environmental Scientist for Vanasse Hangen Brustlin, Inc. ("VHB").
3. VHB has been working closely with the Docket No. 382 applicant, Cellco Partnership d/b/a Verizon Wireless in its application to construct a telecommunications facility off Lane Street in Shelton, Connecticut.
4. Under my direction and supervision, VHB was responsible for the posting of the "Public Notice Sign" at the subject property. In accordance with Connecticut Siting Council ("Council") guidelines, the sign was posted on September 17, 2009, more than ten (10) business days prior to the scheduled public hearing on October 6, 2009.
