Dinner will be at the Rathskeller Restaurant at 88 Main Street South in Southbury (see map).



Directions to Site

Site is located at 316 Perkins Road in the northwestern corner of Southbury.

From Hartford, Norfolk, Enfield, Meriden, Wolcott, and New Britain

- Take I-84 westbound to Exit 14
- From exit ramp turn right onto Route 172 (South Britain Road)
- Follow Route 172 to Spruce Brook Road, turn left onto Spruce Brook
- After approximately 1.2 miles, bear right to follow Spruce Brook Road (straight ahead will be Stillson Road)
- At next corner, turn left onto Purchase Brook Road
- At next intersection, turn right onto Brown Brook Road
- Where Brown Brook Road turns left, stay to go straight onto Perkins Road
- Perkins Road will turn left, after a short distance there will be a small cul-de-sac-like area where there is a gravel driveway straight ahead and a paved road to the right; park in this area; site is down gravel driveway

From Fairfield

- Take I-95 eastbound to Route 8 northbound to Route 25 northbound to Newtown
- At flagpole in center of Newtown turn right onto Route 6 and follow to I-84
- Get on I-84 eastbound and follow to Exit 14
- From exit ramp turn left onto Route 172 (South Britain Road)
- Follow Route 172 to Spruce Brook Road, turn left onto Spruce Brook
- After approximately 1.2 miles, bear right to follow Spruce Brook Road (straight ahead will be Stillson Road)
- At next corner, turn left onto Purchase Brook Road
- At next intersection, turn right onto Brown Brook Road
- Where Brown Brook Road turns left, stay to go onto Perkins Road
- Perkins Road will turn left, after a short distance there will be a small cul-de-sac-like
 area where there is a gravel driveway straight ahead and a paved road to the right;

From Milford

- Take Milford Parkway to Route 15 (Wilbur Cross/Merritt Parkway) westbound to Route 8 northbound to Route 25 northbound to Newtown
- At flagpole in center of Newtown turn right onto Route 6 and follow to I-84
- Get on I-84 eastbound and follow to Exit 14
- From exit ramp turn left onto Route 172 (South Britain Road)
- Follow Route 172 to Spruce Brook Road, turn left onto Spruce Brook
- After approximately 1.2 miles, bear right to follow Spruce Brook Road (straight ahead will be Stillson Road)
- At next corner, turn left onto Purchase Brook Road
- At next intersection, turn right onto Brown Brook Road
- Where Brown Brook Road turns left, stay to go onto Perkins Road
- Perkins Road will turn left, after a short distance there will be a small cul-de-sac-like
 area where there is a gravel driveway straight ahead and a paved road to the right;

From Stonington

- Take I-95 southbound to Milford Parkway to Route 15 (Wilbur Cross/Merritt Parkway) westbound to Route 8 northbound to Route 25 northbound to Newtown
- At flagpole in center of Newtown turn right onto Route 6 and follow to I-84
- Get on I-84 eastbound and follow to Exit 14
- From exit ramp turn left onto Route 172 (South Britain Road)
- Follow Route 172 to Spruce Brook Road, turn left onto Spruce Brook
- After approximately 1.2 miles, bear right to follow Spruce Brook Road (straight ahead will be Stillson Road)
- At next corner, turn left onto Purchase Brook Road
- At next intersection, turn right onto Brown Brook Road
- Where Brown Brook Road turns left, stay to go onto Perkins Road
- Perkins Road will turn left, after a short distance there will be a small cul-de-sac-like area where there is a gravel driveway straight ahead and a paved road to the right; park in this area; site is down gravel driveway

Directions to Hearing

Hearing is at Southbury Town Hall, 501 Main Street South.

From Site

- Retrace steps to Route 172; turn right onto 172
- At traffic light, turn left onto Main Street South
- Town Hall will be on right at 501 Main Street South

From I-84

- Take Exit 14; turn right onto Route 172 from westbound I-84; turn left onto Route 172 from eastbound I-84
- At first traffic light, turn right onto Main Street South
- Town Hall will be on right at 501 Main Street South

Directions to Restaurant

- Dinner is at Rathskeller Restaurant, 88 Main Street South, 203-264-0186
- From Town Hall turn right onto Main Street South
- From Main Street South, turn left onto Poverty Road
- After left onto Poverty Road, turn into first driveway on right
