

Pre-Hearing Interrogatories for Intervenor Pocket Wireless, Set One

1. What are Pocket's licensed operating frequencies in this part of the state?
2. What is the design signal strength for Pocket's system for in-vehicle coverage? For in-building coverage?
3. What is the existing signal strength in the area Pocket would serve from this proposed site?
4. What would be the total area Pocket could cover from the proposed site?
5. What are the respective lengths of Pocket's existing coverage gaps on I-91, Route 40, and the Wilbur Cross Parkway that Pocket seeks to cover from the proposed facility?
6. What is the distance Pocket could cover on I-91 from the proposed site? On Route 40? On the Wilbur Cross Parkway?
7. Identify, by address, sites with which Pocket's antennas at the proposed site would hand off signals – include type and height of structure and height of Pocket's antennas on each structure and distance and direction from the proposed tower.
8. What is the minimum height at which Pocket could achieve its coverage objectives from the proposed site?
9. Provide a propagation map showing what Pocket's coverage would be at 10 feet below its antennas' proposed heights at the proposed site.
10. What is the approximate cost of the antennas and related equipment that Pocket would install at the proposed facility?
11. What would Pocket use for backup power at this site?
12. Of the towers listed in Exhibit I of Phoenix's application, how many does Pocket have antennas on? How many does Pocket plan to install antennas on?
13. The coverage maps submitted as part of Phoenix's application identify sites in the vicinity of the proposed site as "pending on-air sites." Are any of these sites currently on-air? If so, which ones?
