Directions to Site

Site is located at 50 Devine Street in North Haven.

From Hartford, Norfolk, Enfield, Meriden, Wolcott, and New Britain

- Travel I-91 southbound to Exit 10 (Mt. Carmel/Hamden, Route 40)
- Take Exit 10 to follow Route 40 westbound
- From Route 40, take Exit 1 (Dixwell Avenue/Route 5)
- Turn right at end of exit ramp onto Devine Street
- At intersection with Route 5 (State Street), go straight across Route 5 to follow Devine Street
- Continue to end of Devine Street across railroad tracks
- Site will be on property at end of Devine Street

From Fairfield, Milford, Stonington

- Travel I-91 northbound to Exit 10 (Hamden/Cheshire)
- Follow Exit 10 to travel westbound on Route 40
- From Route 40, take Exit 1 (Dixwell Avenue/Route 5)
- Turn right at end of exit ramp onto Devine Street
- At intersection with Route 5 (State Street), go straight across Route 5 to follow Devine Street
- Continue to end of Devine Street across railroad tracks
- Site will be on property at end of Devine Street

Directions to Hearing

Hearing is at the North Haven Public Library, 17 Elm Street.

From Site

- Return to Route 5 and turn left onto Route 5
- At first traffic light after going under bridge, turn right onto Dixwell Avenue
- Immediately take first right to get on Route 40 traveling eastbound
- On Route 40, follow signs to Bailey Road
- At first traffic light, turn left from Bailey Road onto Elm Street
- Library will be large brick building with blue roof on right at corner of Linsley Street

From I-91 Southbound

- Take Exit 12 to Route 5 (Washington Street)
- Turn left at end of exit ramp to travel south on Route 5/Washington Street
- When Route 5 turns right, continue straight ahead onto Church Street
- Turn right onto Linsley Street
- At end of Linsley Street, turn right onto Elm Street – Library will be large brick building with blue roof on right

From I-91 Northbound

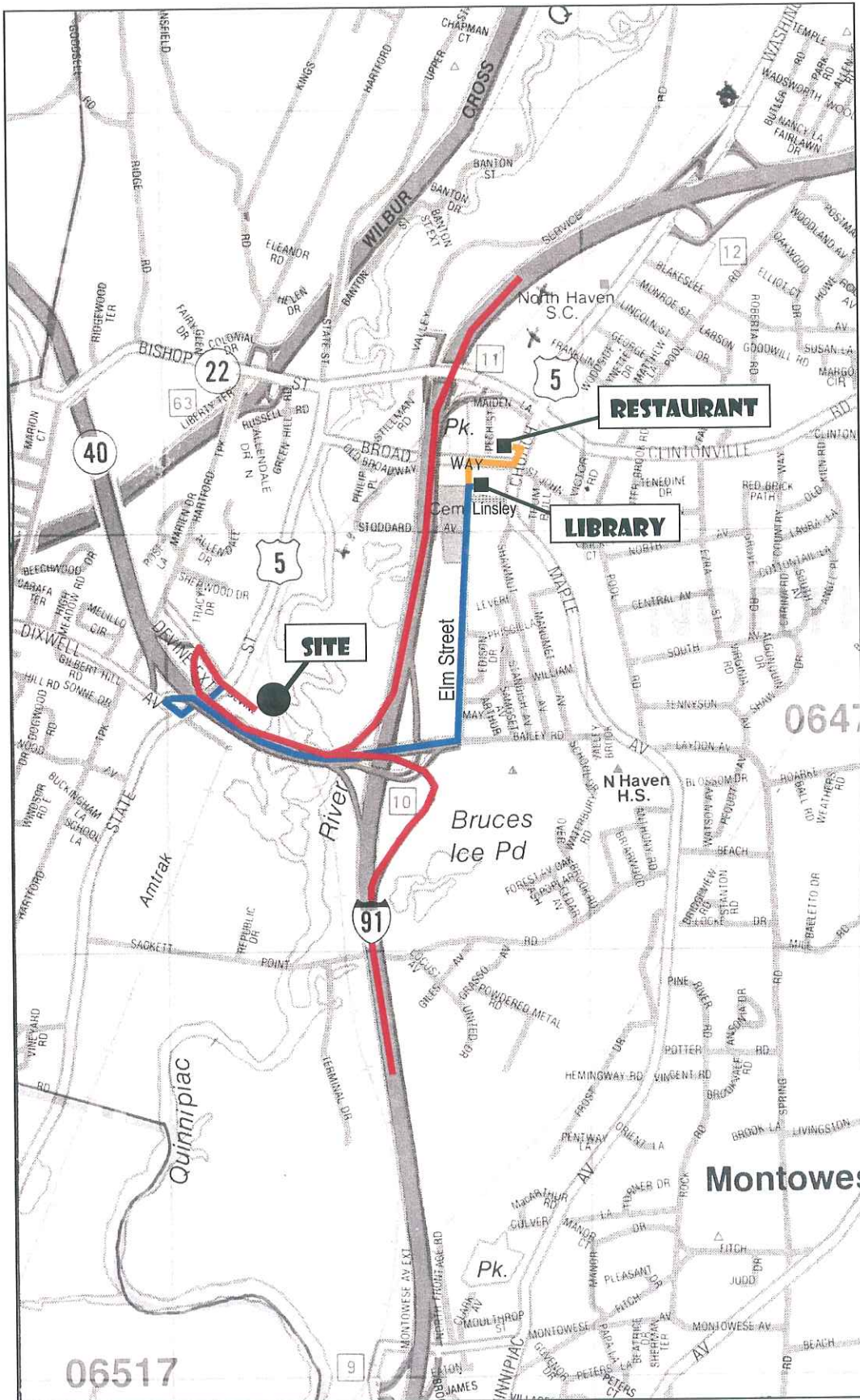
- Take Exit 11 (Route 22/North Haven)
- At first intersection after exit, turn right onto Church Street
- From Church Street, turn right onto Linsley Street
- At end of Linsley Street, turn right onto Elm Street – Library will be large brick building with blue roof on right

- From Library, turn right onto Elm Street
- From Elm Street, take first right onto Broadway
- At next traffic light, turn left onto Church Street
