Notice is hereby given that the transcript of the hearing was received at the office of the Connecticut Siting Council on December 10, 2009.

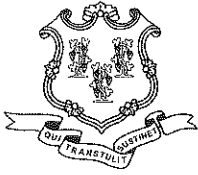


Dear Mr. Sturtz:
