TO FIELD REVIEW

Via Interstate 91 Southbound (Hartford/Meriden region)

Follow I-91 south to the Merritt Parkway at Exit 17.
Follow Merritt Parkway south to Route 8 south at Exit 52.
Follow directions below.

Via Route 8 Southbound (Waterbury region)

Follow Route 8 to Exit 7 (White Plains Road).
At end of exit ramp, turn left.
Take next left onto Broadbridge at traffic light.
Follow Broadbridge about two miles, passing Citgo.
Turn right onto Stonybrook Road– Tech TV on corner in plaza. (before Shell gas station).
Park to rear of plaza.

Via Interstate 95 (Fairfield, New Haven, New London regions)

Northbound - Take exit 32 and go around Rotary to proceed on West Broad Street under the highway overpass.

Southbound - Take exit 32 and turn left. Proceed to West Broad Street at light.
Turn right onto West Broad Street.

Follow West Broad Street to end at Barnum Avenue (Route 1).
Turn right onto Barnum Avenue and go to next light.
Take left onto Broadbridge at light. (7-11 on corner)
Follow Broadbridge about $\frac{3}{4}$ mile and turn left onto Stonybrook. (Just after Shell gas)
Site is behind plaza to left.

TO MUNICIPAL COMPLEX FROM SITE (468 Birdseye Street)

From plaza, proceed to Broadbridge and turn right.

Follow Broadbridge to Barnum Ave at traffic light.

Proceed straight across Barnum, bearing right onto Rockwell (keep 7-11 to right).

Take left onto West Broad Street at second stop sign.

Follow West Broad Street through Rotary (bear left in rotary to continue straight onto West Broad St.).

Turn right onto Main Street at traffic light.

Proceed south on Main Street to third traffic light.

At third light, take sharp right onto Birdseye Ave.

Municipal Complex is brick building on right. Enter building on right side.

TO MUNICIPAL COMPLEX FROM INTERSTATE 95

Northbound - Take exit 32 and bear right in Rotary to proceed on West Broad Street. West Broad Street ends at Main Street.

Southbound - Take exit 32 and turn left. Proceed to West Broad Street at light. Turn left onto West Broad Street and follow West Broad through rotary to Main Street.

Turn right onto Main Street and proceed to third traffic light.

At third light, take sharp right onto Birdseye Ave.

Municipal Complex is brick building on right. Enter building on right side.

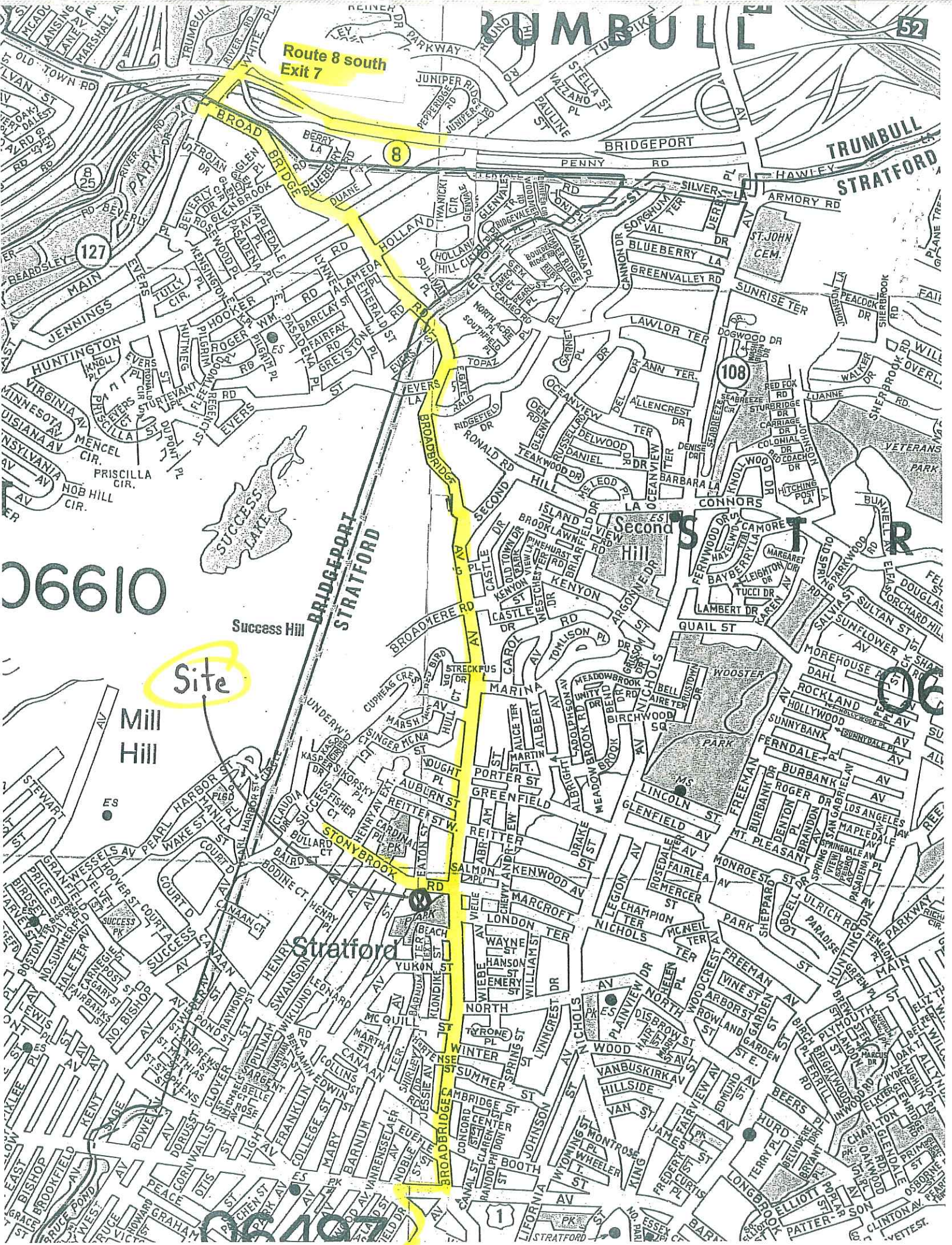
Directions to Duchess Diner

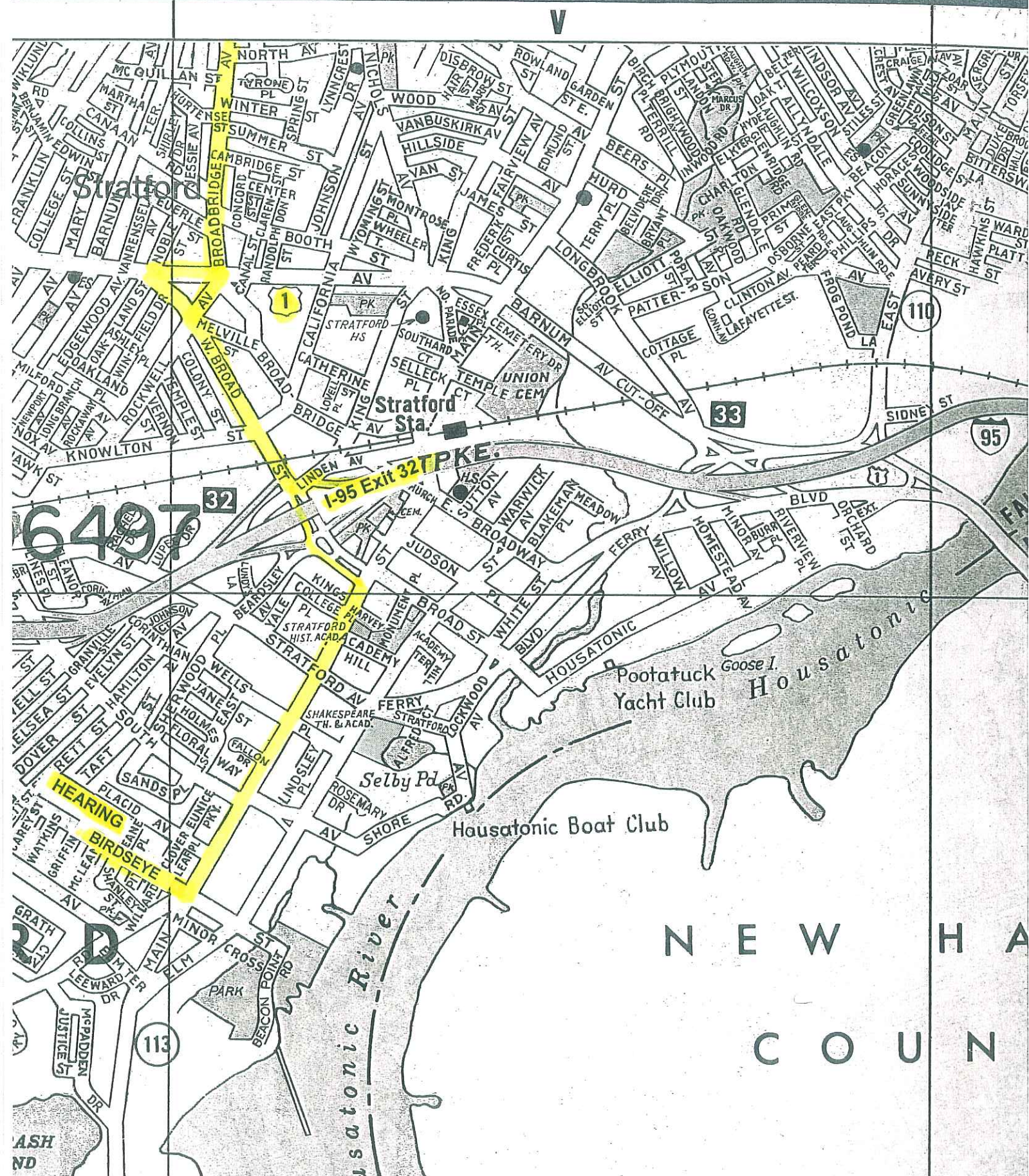
