### **TO FIELD REVIEW**

#### **From Interstate 95 (New Haven, Old Saybrook)**

Follow I-95 to Exit 55.

At end of ramp, follow Route 1 south.

Travel approx. ¼ mile on Route 1 south and turn left onto Windmill Hill Road (traffic light).

Follow to end and take right onto Damascus Road (Route 146).

Travel approx. 0.9 mile and turn left onto Pine Orchard Road.

Follow 0.3 miles to 123 Pine Orchard Road on right. (across from Knollwood)

#### **TO MUNICIPAL COMPLEX FROM SITE (46 Church Street)**

From site, turn left onto Pine Orchard Road and follow to T intersection.

Turn left at intersection, following Pine Orchard Road to Montowesse Road.

Turn right onto Montowesse Road take first left onto Meadow Street.

From Meadow Street, take first right onto Church Street, passing brick municipal building on left.

Turn left onto Prospect Street to park at rear of building.

All-Purpose Room is on second level.

#### **TO MUNICIPAL COMPLEX FROM INTERSTATE 95**

Follow I-95 to exit 54, Cedar Street. (If traveling I-95 northbound, turn right onto Cedar Street. If traveling I-95 southbound, turn left onto Cedar Street)

Follow Cedar Street past Route 1 to Main Street.

Turn left onto Main St. and take quick right onto Hopson Ave.

Turn left onto Prospect Street and follow to municipal building parking lot on right.

All-Purpose Room is on second level.

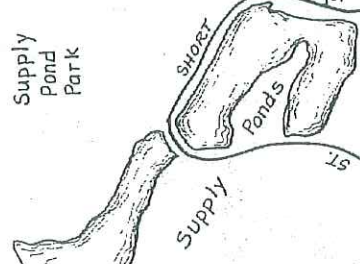
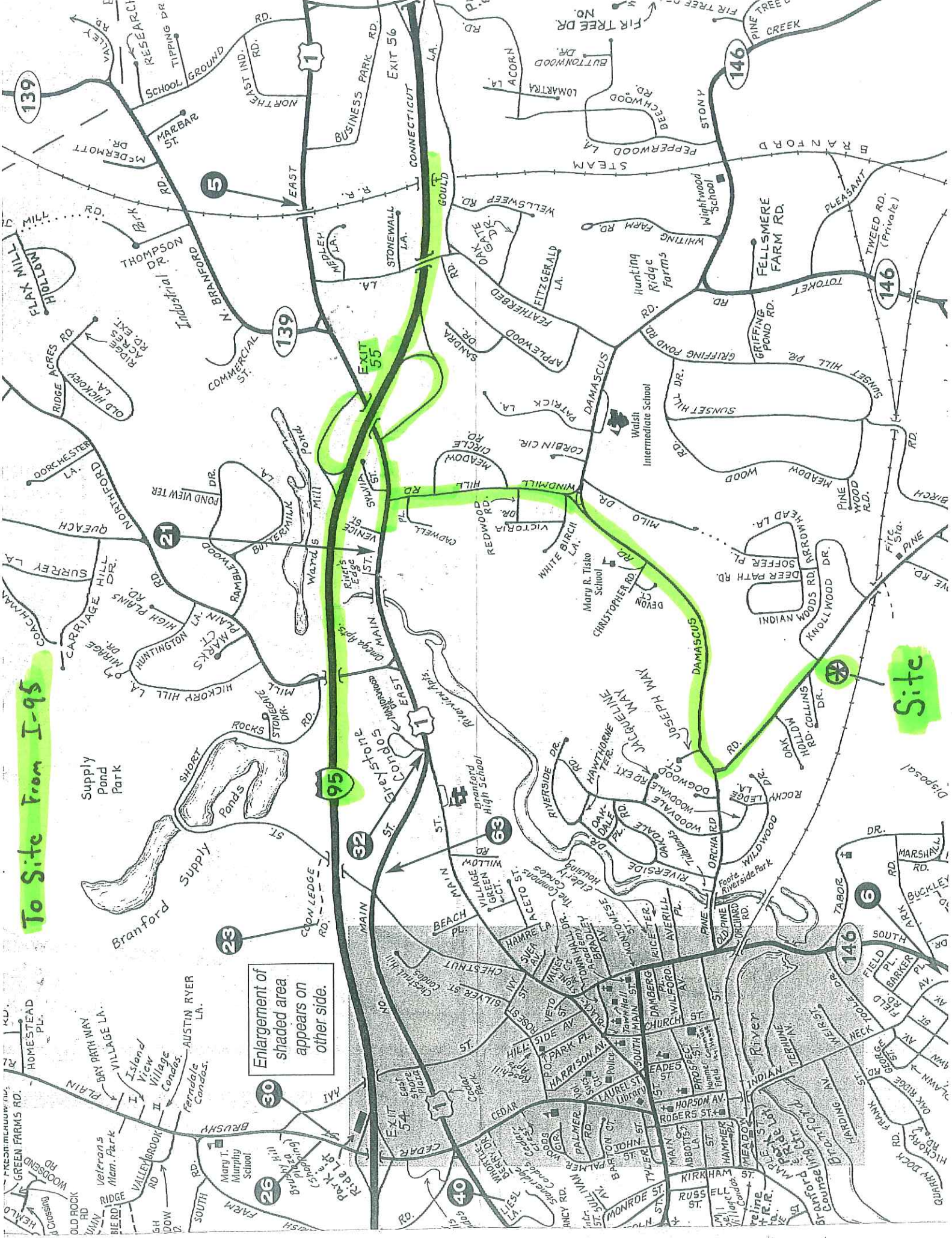
### **Directions to Branford Townhouse Diner**

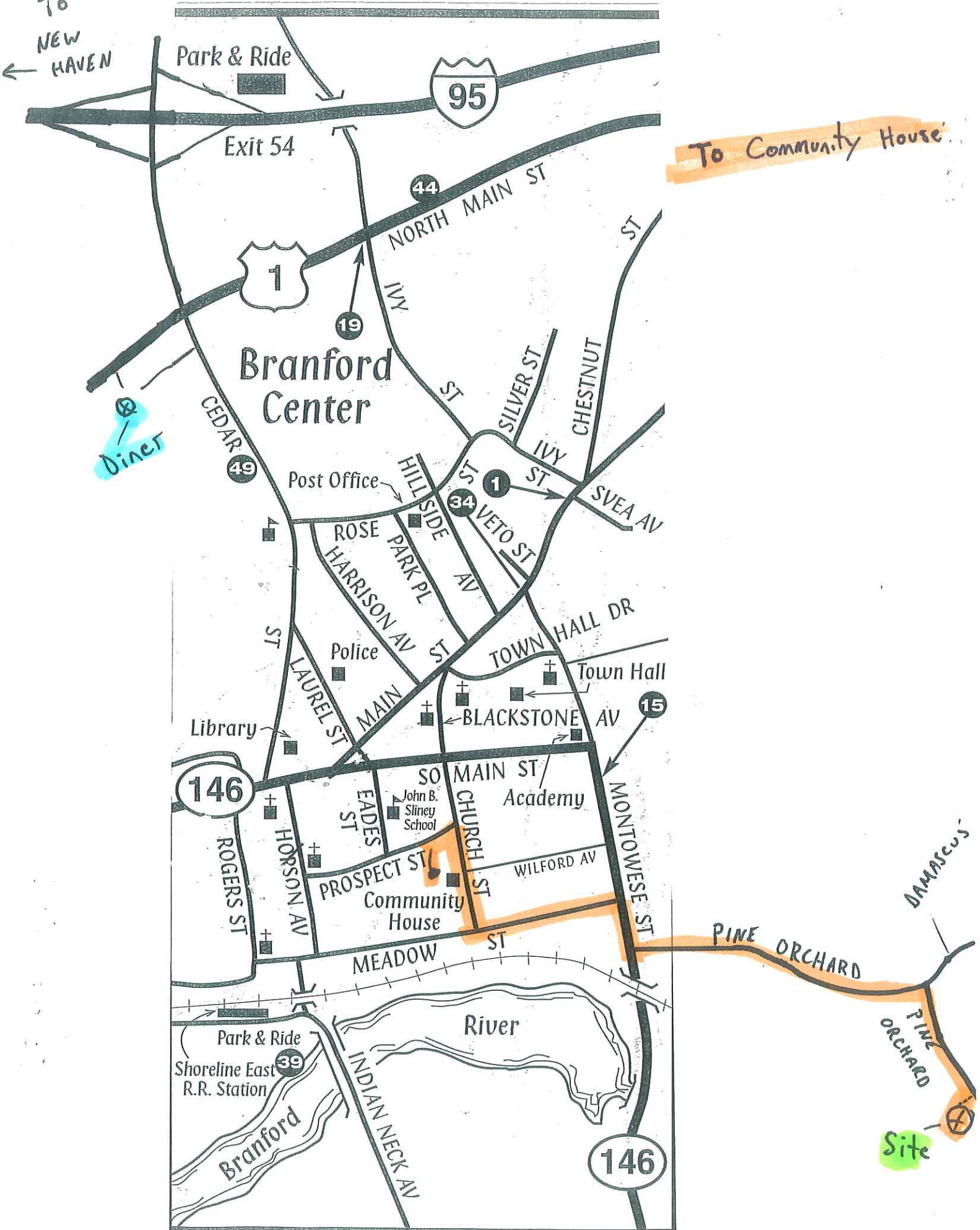
