TO INTERVENE IN THIS PROCEEDING

Pursuant to Section 16-50n of the Connecticut General Statutes and Section 16-50j-15a of the Regulations of Connecticut State Agencies, New Cingular Wireless PCS, LLC ("AT&T") respectfully requests permission of the Connecticut Siting Council ("Council") to participate, as an intervenor, in the application and hearing process for SBA Tower II, LLC 's application for a certificate of environmental compatibility and public need for the construction maintenance and operation of a telecommunication facility in the Town of Barkhamsted, Connecticut.
